


Latimer Road Underground Station which operates on the Circle and Hammersmith and City Lines is within 6 minutes' walk enabling a regular service to Central London. The property is in close proximity to the A3220 which connects to The Westway A40(M) providing links to the London Inner Ring and the West London Suburbs.
