

The Port of Barry is located approximately 9 miles west of Cardiff and is accessed via the B4267 and the A4055. Junction 33 of the M4 Motorway is located approximately 10 miles to the north and is accessed via the A4050 and the A4232 dual carriageway. The Port benefits from passenger and freight rail links to both Cardiff city centre (to the east) and Cardiff Airport (to the west).
