Description

Unit 44 is a prominent light industrial / warehouse / trade counter unit visible from the main estate road. The units on the estate are of steel frame / truss construction with elevations predominately of brick/blockwork and profile steel sheeting. The pitched roofs are clad in profiled sheeting incorporating translucent panels. Access to the units are via steel roller shutter loading doors and separate pedestrian door.

Location

Strategically located within the Rhondda Valley - established industrial / distribution and trade location. Gelli Industrial Estate is located in the Rhondda Fawr Valley, approximately 3 miles north west of Porth and 2 miles north of Tonypandy.
