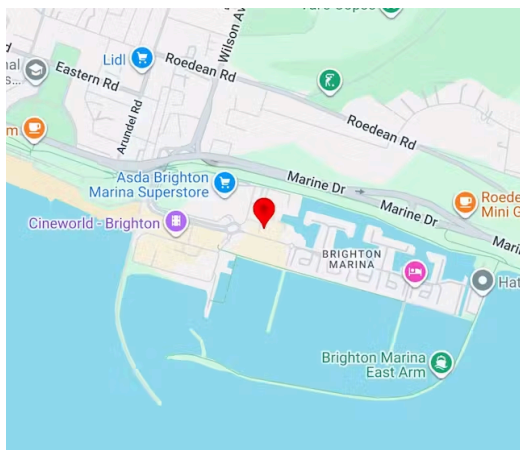

## Description

An imposing & character building that has traded previously as a public house built in the style of a character barn. The property is arranged predominately over 3 levels with main bar & cool room at ground floor level, kitchen & function room at 1st floor & additional storage space on the half landing & 2nd floor. The property benefits from impressive waterside views with boats moored adjacent to the site. Whilst the property has been used as a pub since its inception subject to consent we feel that it could be suitable for a variety of uses including, office, education, retail or leisure.

## Location

The property is situated on the northern side of Brighton Marina (the largest marina in the UK) in The Marina Square, just east of Asda. The unit is surrounded by operators such as Nando's, Laughing Dog café, Kutchenhaus, WED2B wedding dress shop & Mal Maison Boutique Hotel. Hollywood Bowl Bowling Alley, an 8 Screen Cineworld Cinema & David Lloyd Gym are also located within The Marina development. The Marina is situated to the east of Brighton City Centre & can be accessed easily by car, bus or on foot. Brighton Marina is a 127 acre site with a 1,500 space, multi storey car park, over 1300 berths & over 800 residential dwellings.

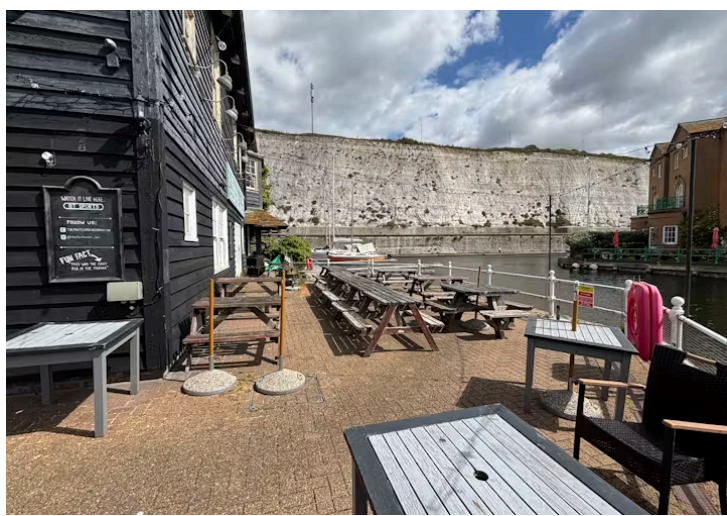

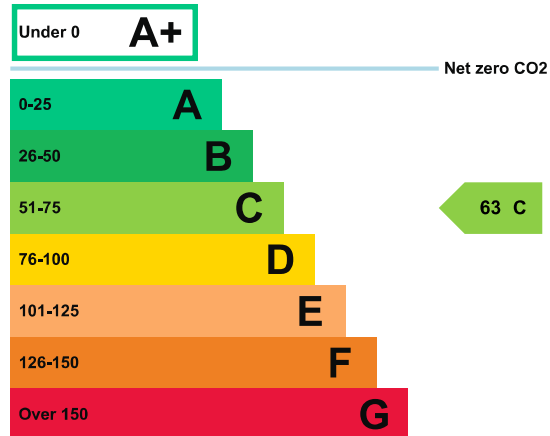

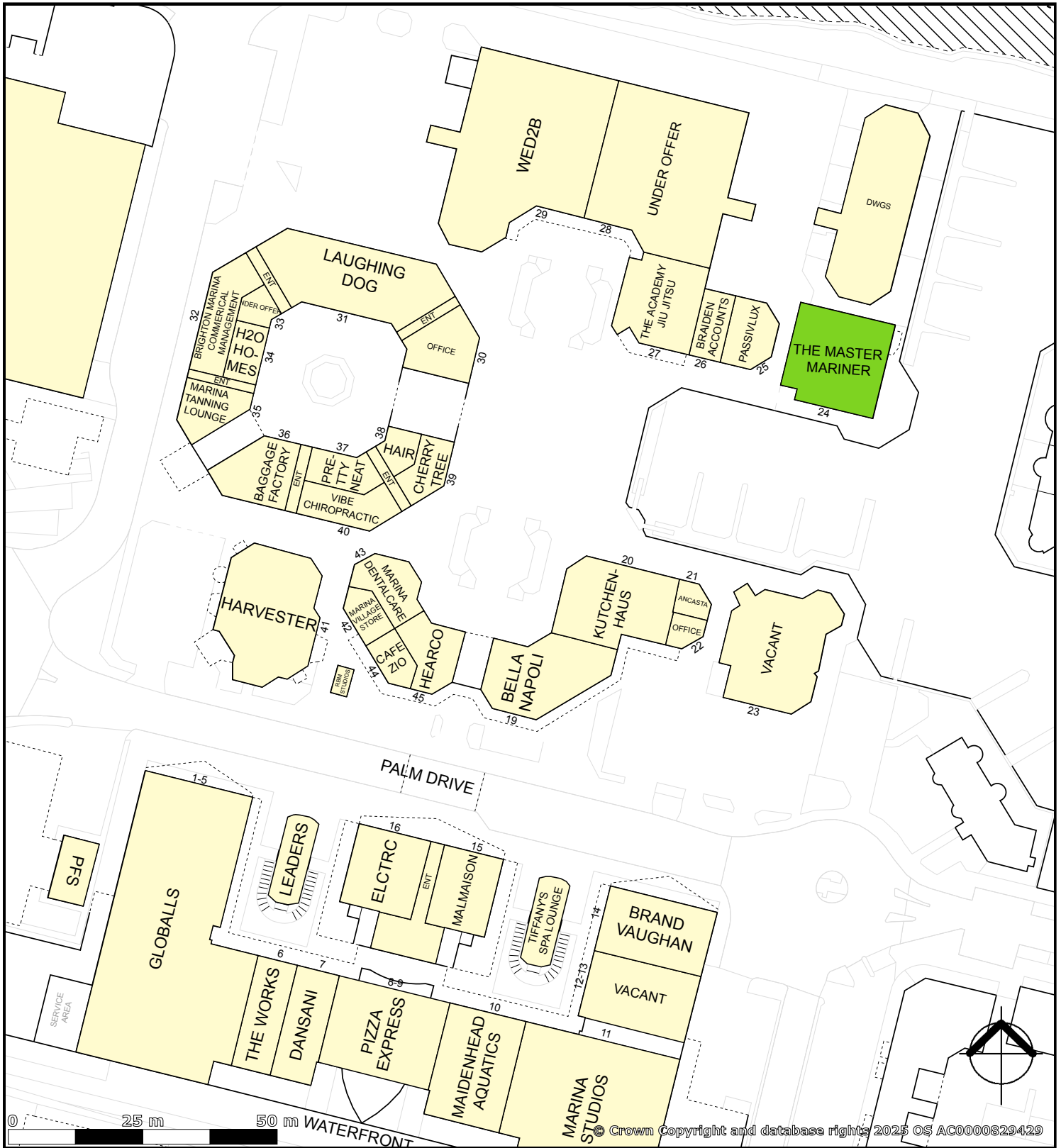
