LOCATION

Berol House is located at the northern end of Ashley Road, which provides access to the North Circular (A406) and High Road Tottenham (A10) in the south. Tottenham Hale National Rail and Underground Stations are a short walk to the south and offer connections to Central London on the Victoria Line (King's Cross Station in 10 minutes).

DESCRIPTION

Built in 1907, Berol House comprises a mixed use building of traditional masonry construction, arranged over three floors and offers office and retail space.

The Ground, 1st and 2nd floors have been split to offer a series of smaller office spaces which have been occupied by tenants including North London Waste Authority, Migrant Resource Centre and Seafarer Holidays.


