Location

Denmark Trade Park is a new development comprising 3 trade counter / warehouse units situated within the established Forstal Road Estate. Access is via Beddow Way and the units front Forstal Road which provides direct access to Junction 6 of the M20 within 1 mile. The M20 provides access to the M25 junctions 3 & 5 circa 20 miles to the west and the Channel Tunnel and Ports within 30 miles to the east. Maidstone town centre is within 3 miles.

Other occupiers nearby include CEH Plant Hire, GAP Plant Hire, Travis Perkins, City Electrical Factors and Waitrose.

Description

The units comprise a single terrace of 3 warehouse / trade counter units of steel frame, profile metal cladding and roof lights with an eaves height of 7.5m (25ft) rising to the rear to 9m (30ft). Each unit benefits from a 4.8m high loading door, 2 storey fully glazed personnel entrance, 3 phase power, capped drainage and mains services, 7 designated car parking spaces per unit and loading to the front.
