Magnificent Grade II listed former bank which dates to 1836 and now offers an occupant a restaurant opportunity with the potential for up to 100 covers. Under the proposed scheme, entry is made through the main front entrance with space for a bar/reception, main dining hall with mezzanine, kitchen, toilets and ancillary spaces, with the potential for offices or function rooms to the second floor. The ground and first floor levels total 4273 sq/ft (396.98 sq/m) with the potential for a mezzanine of approximately 645 sq/ft and feature an ornately coved former banking hall, of which there is no parallel in the local area.

The premises are located in the traditional district of Bury town centre close to many of the town's most established businesses, including the Fusilier's museum, solicitors firms, Bury library and other bars and restaurants.
