JOB PURPOSE:

Clan Therapists will be required to provide advanced therapeutic assessment of individuals with a cancer diagnosis and those without a diagnosis but who are affected by cancer. Individuals with a cancer diagnosis may present with complex physical, emotional and psychological needs as a result of their cancer diagnosis and its treatment with surgery, radiotherapy and chemotherapy. Others affected by a cancer diagnosis also may require therapeutic intervention to assist with their own wellbeing needs. All therapists require to develop and deliver individualised complementary therapy programmes for those accessing Clan's Services.

KEY RESPONSIBILITIES & DUTIES:

- As a practicing therapist, provide one or more therapies to Clan clients and carers.
- Prioritise and manage complementary therapy referrals and coordinate the workload.
- Ensure a robust referral, assessment, review and discharge process is in place in order to effectively manage the service and client outcomes in line with Clan's Client Pathway.
- The ability to work alongside colleagues to review and develop the therapy offering based on credible therapeutic interventions recognised by the NHS.
- Represent Clan on any relevant groups or forums designed to develop therapeutic interventions with cancer clients.
- Provide listening and support to any clients who need to talk prior, during or after a therapy.
- Work within Clan's policies and procedures and adhere to Clan Values at all times.
- Flexible working approach to ensure the therapeutic delivery of services is accessible to clients.
- Maintaining client records adhering to the systems in place and Clan GDPR and recording policies.

This list is not exhaustive and other duties will be required to be undertaken from time to time to ensure the effective delivery of responsibilities associated with the post and working for Clan.
