With the introduction of the Chiropractor's Act which gave Parliamentary recognition to the profession, the General Chiropractic Council which regulates the profession and with other active professional bodies on board, including the Royal College of Chiropractors, the profession is closer to being fully recognised as part of mainstream medical practice than

Although most chiropractors are currently in private practice, the latest NHS guidelines advocate chiropractic healthcare and welcome the practice into mainstream healthcare. Whilst chiropractic care under the umbrella of the NHS is at an embryonic stage, private chiropractic is a fast-growing profession with increasing numbers of patients benefiting from the therapy it provides.
