Entry requirements

Educational background

- A minimum of a 2:2 Honours degree from a UK or recognised international university or another equivalent international qualification; or
- An acceptable professional qualification equivalent such as the CMI, ILM, CIM, CIMA at level 6 or above

English language requirements

- IELTS 6.5 (overall) or equivalent, plus a minimum of 6.0 in all components

If you have the minimum of 6.0 in any component, you will be required to undertake a compulsory In-Sessional English/Academic English course during the first term of your studies.

If you do not meet the English language requirements, you may be eligible to join one of BPP University's English language or foundation programmes.
