Conditions of offer Group Discounts:

1. This offer is only available in accordance with these Terms and Conditions and to international students from overseas who apply for the Course from overseas and who (“**Customers**”):
 - a. For the Group Discount I: form a group of five international students and apply on or before 30 April 2017 (for a 30% discount) or after midnight GMT on 30 April 2017 (for a 10% discount);
 - b. For the Group Discount II: form a group of ten international students and apply on or before 30 April 2017 (for a 40% discount) or after midnight GMT on 30 April 2017 (for a 20% discount).
2. All Customers must meet the admission criteria for the relevant Course.
3. The Offer consists of a discount on the standard Dental Summer School fee of £5,000 for a four-week Course.
4. The Offer may be only redeemed at BPP’s Colmore Circus Centre in Birmingham, 34-36 Colmore Circus Queensway, Birmingham B4 6BN (“**Selected Centre**”).
5. The Offer does not include any other discount or financial benefit to Customers and does not apply to amounts payable to the professional body for student/delegate registration, exemptions and examination entries.

 - b. For the Group Discount I, where Customers apply after midnight GMT on 30 April 2017, reference: '10 % Group Discount'.
 - c. For the Group Discount II, where Customers apply on or before 30 April 2017, reference: '40 % Group Discount'.
 - d. For the Group Discount II, where Customers apply after midnight GMT on 30 April 2017, reference: '20 % Group Discount'.
11. The Offer can only be redeemed against a new qualifying booking onto the Course from a Customer who has not already booked a place on the Course.
12. Customers cannot use this Offer in conjunction with any other discounts or offers by BPP. Group discounts cannot be combined. Group discounts and scholarships cannot be combined.

Amendments/cancellation
