CHRISTMAS BOOKING TERMS & CONDITIONS 2018

Please complete and return this form to make your booking. Your booking will only be confirmed in writing by us once credit card details have been received

To confirm this booking & your acceptance of these Terms and Conditions the attached form must be completed & returned to us. Your conditions of booking (if any) shall not apply to this contract. No variation of, or in addition to, these terms shall take effect unless agreed in writing by us.

1. Credit Card and Non-refundable Deposit

- 1.1) A credit card must be left against the booking.
- 1.2) A deposit of £10 for each guest is payable to confirm the booking.
- 1.3) The deposit is payable for the number of guests stated on the booking form, and any additional guests subsequently agreed with us in writing.
- 1.4) The deposit for each guest will be deducted from the credit card provided by you on our receipt of the booking form. Where additional guests are agreed with us, the deposit for each additional guest shall be deducted from the credit card provided on the day of the event.
- 1.5) The deposit is non-refundable for each of the guests on the booking form and for any additional guests agreed with us, regardless of any subsequent changes to the number of guests.

2. Confirmation and Payment

- 2.1) We will confirm your booking in writing once the deposit has been taken.
- 2.2) The balance of the account for the booking is payable on the day of the event.

3. Cancellation and Variation to the Booking

- 3.1) Any cancellation or variation to the booking (e.g. changes to the number of guests) must be made in writing 7 days prior to the event.
- 3.2) Where the booking is cancelled or varied without 7 days' notice, full payment of the menu price less the deposit for each guest on the booking form and any agreed additional guests, will be taken from the credit card provided on the day of the event.

4. Service Charge

- 4.1) A discretionary 12.5% will be added to your bill.

5. Christmas Bookings - Menu Choice

- 5.1) You have to select one of the following set menus at the specified price per head:

Christmas Individual Menu | £37 per person
Christmas Sharing Menu | £37 per person
Christmas Vegetarian Sharing Menu | £37 per person
Christmas Tequila Dinner Menu - £59 per head

6. Free-Flowing Drinks - Only valid with Christmas Menus

- 6.1) One drink per person at any one time. We operate a 2 ¼ hour return time from reservation time on all tables. Free-flowing drinks only valid with Christmas menus not a la carte. No drinks will be severed after 1 hour 45 minutes from the reservation time under the free-flowing drinks offer. Drinks under this offer are to be consumed only by the person paying the free-flowing drinks supplement. Guests are responsible for making sure that they drink alcohol responsibly. Our staff are trained to serve alcohol responsibly in terms of the Licensing Act 2003 in England and Wales.

7) Non-Christmas Bookings for 7 persons and over

For non-Christmas Bookings of 7 persons and over between 1st and 24th December, guests may choose from one of the following Group Menus:

Group Menu A Sharing | £34 per person
Group Menu B Sharing | £44 per person
Group Menu C Individual | £34 per person
Group Menu Vegetarian | £34 per person
Free-Flowing Brunch Menu | £50 per person (only available Saturday and Sunday 12 noon to 4pm)

*Please note the free-flowing drinks offer is not available with any group menus

8. Payment

- 8.1) Payment can be taken from a number of guests provided the bill is split equally between the numbers of guests, up to a maximum of 10 payments. Where people pay for what they have ordered, the party organiser must collect all payments and settle the bill in full with the waiter. The person making the booking is responsible for settlement of the bill in full. Where settlement is not made in full on the date of the event any shortfall will be taken from the credit card provided on the booking form or the credit card used by the organiser on the night. The organiser must pay by credit card.

9. External Cakes

- 9.1) We do not permit guests to bring in their own externally sourced celebration cakes into Cantina Laredo for health and safety reasons. If you are celebrating a birthday or significant event please let us know when booking and we can arrange for a "Happy Birthday/Celebration" plate with a candle when you order a dessert.
