

## Payment Routing Instructions – All Currencies

You may deposit currencies into your account(s) with Cayman National Bank (Isle of Man) Limited (the “Bank”) by electronic transfer quoting your account name and number with us.

This guide provides details of the bank routing that you will need to choose, together with the correct account number, depending upon the currency that is being sent. Please also refer to the Bank’s Terms and Conditions and its Schedule of Fees and Charges for further information about how we process incoming payments and any fees or charges that may apply.

### 1. DOMESTIC STERLING PAYMENTS

#### Within the UK, Isle of Man or Channel Islands ONLY

When sending Sterling (GBP) to an account with the Bank from within the UK, Isle of Man or Channel Islands via BACS, CHAPS or Faster Payment please use the following routing:

### 2. INTERNATIONAL CURRENCY PAYMENTS

#### Bank Routing Details

When sending currency payments to your account with us, whether by SWIFT or other payment mechanism, please use the following routing:

### 3. INTERNATIONAL BANK ACCOUNT NUMBER (IBAN)

The **International Bank Account Number (IBAN)** is an internationally agreed system for identifying bank accounts across national borders. In addition to identifying a bank account number it also identifies the bank/branch and country in which it is located.

The **IBAN** system was initially used by the European Union to facilitate payments made between member countries. It has since been adopted internationally, under ISO standard 13616:2007, for use when making SWIFT payments. The use of IBANs helps to reduce the possibility of a payment being sent to the wrong account or bank in error.

The use of an **IBAN** is not compulsory in the Isle of Man. However, if sending money to (or receiving money from) a European Union Member State the use of an IBAN is obligatory.

If you wish to establish the **IBAN** for your account with Cayman National please go to <https://www.iban.com/calculate-iban.html> and:

1. Select 'United Kingdom' for the country;
2. Enter the Bank's Sort Code 60-83-99; and
3. Type in your 8-digit bank account number with Cayman National; and
4. Select 'Calculate'

You will then be given your 22-digit **IBAN** e.g. GB34CNBT60839901234567.

Note 1: Please refer to Section 3 above for guidance on how to calculate the IBAN for your account.
