

## **Visa Application**

- Visa Application Requirements:
  - Visa applicant's coloured passport copy ( should be valid for more than 6 months)
  - Visa applicant's passport size photograph with white background
  - Guarantor's passport, visa copy & Emirates ID copy (should be valid for more than 3 months)
- Approval of the visa requires up to 3 working days
- No refunds or extensions will be given for unused or expired vouchers
- Visa approval is at the sole discretion of the Immigration Officials and not on Al Majid Travel LLC.
- The voucher is valid for 60 days from date of purchase

### **Terms and Conditions by Al Majid Travel LLC.**

1. This facility is available for bona fide tourists visiting the UAE and fulfilling the eligibility conditions as stipulated by the UAE Immigration Authorities.
2. Al Majid Travel LLC has no role whatsoever in the assessment of visa applications, which is the sole prerogative of the government of the UAE. Therefore, Al Majid Travel LLC will not in any manner be liable or responsible for any delay in the processing or rejection of any visa application.
3. In the interest of its applicants, Al Majid Travel LLC reserves the right to reject, without explanation, any application that it feels may not be approved by the UAE Immigration Authorities. In such cases only, any amount paid will be refunded in full within 7 working days.
4. Al Majid Travel LLC. may at its own discretion request a cash security deposit of up to AED5,500 to submit an application. If the applicant is unable to furnish such deposit, Al Majid Travel LLC will refund in full any amount paid within 7 working days. Security deposits will be refunded within 7 working days after the visitor has exited the UAE provided that there are no fines.
5. Issuance and approval of a visa is solely regulated by the government of the UAE and governed by their rules and regulations that may be amended from time to time.
6. Visa fees are non-refundable, and the applicant/visitor will not make any claims to refund the same for any reason whatsoever, save clauses 3 and 4 above.
7. The decision to grant or refuse a visa is the sole prerogative of the UAE Immigration Authorities and it is final. In case of rejection of visa application, the applicant will be informed of the same and no correspondence will be entertained. As advised above, visa fees will not be refunded, and no reasons will be required to be given.
8. It is understood that whenever the processing of the visa application is prevented, delayed, restricted or interfered with for any reasons whatsoever by the UAE Immigration Authorities then Al Majid Travel LLC will not be liable for any loss or damage which may be suffered as result of such causes.
9. Issuance of a visa or approval of the visa application does not in any way guarantee the visitor right of entry to the UAE. The entry is at the sole discretion of the Immigration Officer at the airport. In case of denial of visa or entry into UAE by the Government, Al Majid Travel LLC will in no way be liable to the visitor/guest in any manner whatsoever.
10. The visa is valid as per the government of the UAE's rules and regulations and must be utilised within its period of validity.
11. Al Majid Travel LLC will not be liable to a visitor for any changes or cancellations to government regulations that should result in a visitor not being able to travel to or enter the UAE.
12. Al Majid Travel LLC will take all reasonable measures to ensure that the information provided by the guarantor and visitor in its application form will remain confidential. However, Al Majid Travel LLC will

not be liable for any unauthorised access by any means to that information.

13. The Security Deposit amount should be collected any time within one year from the date of deposit. Upon expiry of the above said duration, the security deposit will not be refunded to the guarantor.
