## Definitions and interpretation

1. In this privacy policy, the following definitions are used:

<b>Data</b>	collectively all information that you submit to Capital Kitchens Renovations Ltd via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
<b>Cookies</b>	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below ( <b>Cookies</b> );
<b>Data Protection Laws</b>	any applicable law relating to the processing of personal Data, including but not limited to the Directive 96/46/EC (Data Protection Directive) or the GDPR, and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the UK;
<b>GDPR</b>	the General Data Protection Regulation (EU) 2016/679;
<b>Capital Kitchens Renovations Ltd, we or us</b>	Capital Kitchens Renovations Ltd, a company incorporated in England and Wales with registered number 10969630 whose registered office is at 77 Avontar road, Essex, RM155FD;
<b>UK and EU Cookie Law</b>	the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011;
<b>User or you</b>	any third party that accesses the Website and is not either (i) employed by Capital Kitchens Renovations Ltd and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Capital Kitchens Renovations Ltd and accessing the Website in connection with the provision of such services; and
<b>Website</b>	the website that you are currently using, <a href="http://www.ckrltd.com">www.ckrltd.com</a> , and any sub-domains of this site unless expressly excluded by their own terms and conditions.

2. In this privacy policy, unless the context requires a different interpretation:

- a. the singular includes the plural and vice versa;

- b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
- c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
- d. "including" is understood to mean "including without limitation";
- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this privacy policy.

### **Scope of this privacy policy**

- 3. This privacy policy applies only to the actions of Capital Kitchens Renovations Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Capital Kitchens Renovations Ltd is the "data controller". This means that Capital Kitchens Renovations Ltd determines the purposes for which, and the manner in which, your Data is processed.

### **Data collected**

- 5. We may collect the following Data, which includes personal Data, from you:
  - a. name;

  - e. web browser type and version (automatically collected);

### **Data that is given to us by you**

## **Data that is collected automatically**

## **Who we share Data with**

  - b. we store your Data on secure servers.

### **Your rights**

18. You have the following rights in relation to your Data:

  - e. **Right to data portability** - the right to request that we move, copy or transfer your Data.
  - f. **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.
