# Minutes of the Town Council Meeting held in the Methodist Church Hall on Thursday 16<sup>th</sup> January, 2020 at 7.30 p.m.

### 125/19 To receive and approve Apologies for Absence

Apologies were received from Cllr. Blacker and approved by the council.

#### 126/19 Declarations of interest

There were none.

127/19 Minutes of the Town Council meeting held on the 12<sup>th</sup> December 2019 to be approved and signed **RESOLVED** that the minutes of the Town Council meeting held on the 12<sup>th</sup> December 2019 be approved as a correct record and signed by the Chair.

**128/19** Public participation session with respect to items on the agenda and matters of mutual interest There was one member of the public present requesting further details on the plans for the upcoming VE 75<sup>th</sup> celebrations on the 8<sup>th</sup> May 2020.

#### 129/19 Reports from the District and County Councils

A monthly update was provided by District Cllr. A. Coley. He asked for the Council's views on rejected planning application 19/00336/OUT to build a new GP super surgery at Mistley, as an appeal application has already been lodged. Although the council supports the need for a larger surgery it was noted that Tendring Farms Ltd's proposed location is not suitable and that such a surgery should be within or nearer to Manningtree town centre. Amongst other concerns, one of the main worries is that by removing the surgery from the town centre, Manningtree will see a drastic decline in footfall, which in turn would have a detrimental effect on the town's High Street.

#### 130/19 Report from Essex Police

Sergeant A. Heard and PC R. Kent provided the Council with an update on the number of reported crimes in Manningtree and the surrounding area over the last month. Sergeant Heard noted that there had been a disproportionate number of motor vehicle thefts recently with a total of 9 such incidents reported since 29<sup>th</sup> December 2019.

Cllr. Tattam asked what their views on the use of CCTV cameras were in town centres and whether they thought installing them may result in crime being shifted to other areas. They replied that whereas CCTV cameras are a deterrent there is certainly a risk the offenders will just be moving their criminal activity elsewhere. It was noted that it would be beneficial to have more police officers out on patrol.

#### 132/19 Report from other committees and representatives

Cllr. Stocks noted that she had been informed that Mistley Parish Council is considering disbanding the Manningtree and Mistley Cemetery committee with a view to Mistley Parish Council dealing with all cemetery related matters going forward. Cllr. Stocks has questioned the decision.

Cllr. Taylor provided an update from the VE 75<sup>th</sup> Anniversary working group. The event will run from 12 p.m. to 3 p.m. culminating with a toast and very short service at the Manningtree War Memorial. The parade has been moved to Sunday 9<sup>th</sup> May. There will be various competitions throughout the day, shop window displays, 1940s dancing, entertainment, catering, stalls and a display of military vehicles. A memorial ribbon will be provided to all children in the local primary schools with parish councils being asked to provide a financial contribution for the cost of these. The clerk was asked to send formal invitations to various local dignitaries. She was also asked to order 10 high vis vests for the event.

#### 133/19 Highways/Environment

a) To consider a request to create a skatepark in the Manningtree area Cllr. Stocks noted that as there is no space for a skatepark within Manningtree itself she had asked the resident to contact Mistley and Lawford Parish Councils.

b) To consider the findings of the recent tree survey carried out

The clerk noted that the recommendations for the larger tree on Quay Street to have its crown reduced by up to 30% was not considered urgent. However, there was an urgent recommendation of re-staking the newly planted tree on Quay Street. **RESOLVED** that the council wait with the pruning of the larger tree but that the clerk requests that the newly planted tree be re-staked.

## c) To consider ways in which Manningtree Town Council can assist in reducing carbon emissions in the local community

Tendring District Council is urging all parish councils to consider planting more trees to aid in carbon offsetting. It was noted that Manningtree does not have any space for further tree planting. Cllr. Taylor asked District Cllr. Coley if TDC have any incentives in place to encourage residents to plant trees in their gardens. Cllr. Coley agreed to investigate. It was also agreed that the clerk is to publish information on the Council's website with tips for residents on how to become more carbon friendly.
