THE 4 IMPORTANT POINTS FOR ALL STAFF TO REMEMBER

- **SOCIAL DISTANCING** (remember it is better to be side by side if having a conversation)
- **FREQUENT HAND WASHING**
- **GOOD RESPIRATORY HYGIENE – CATCH IT BIN IT KILL IT**, Open windows for good ventilation
- **INFORM SCHOOL AND LOCAL HEALTH IF COVID 19 CASE WITHIN CLUB**
