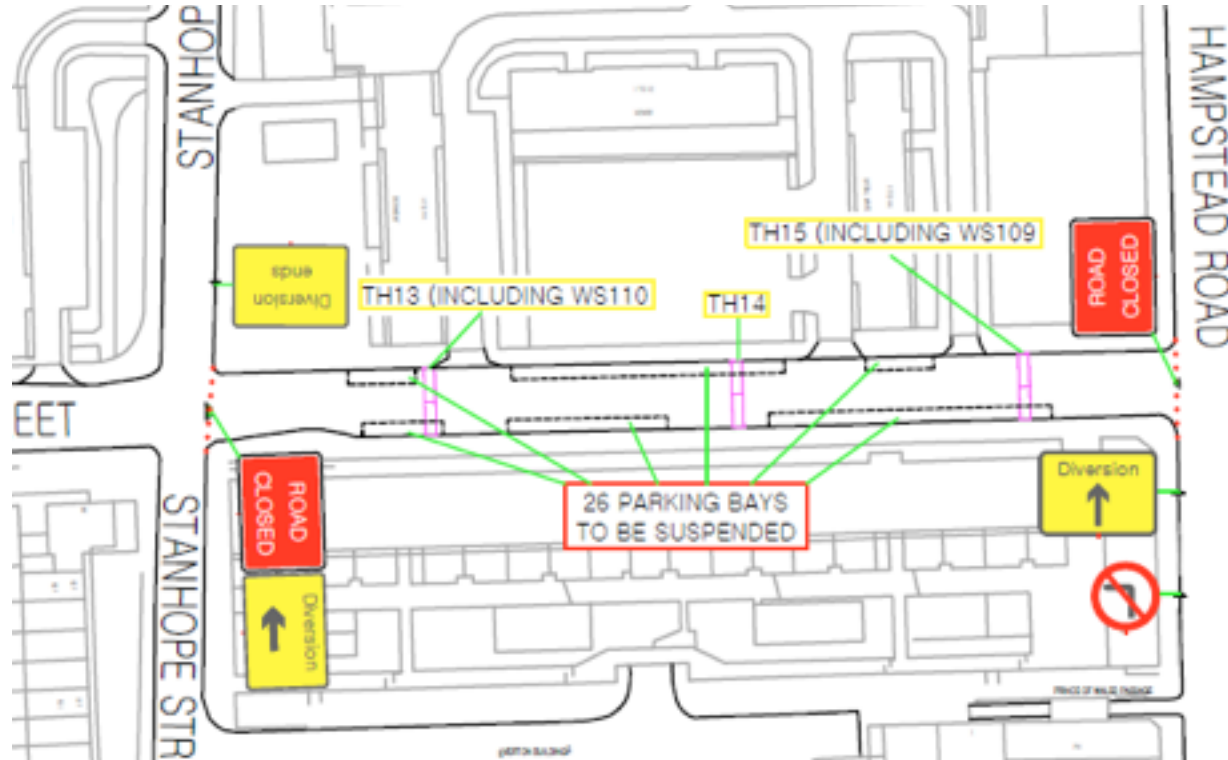

Robert Street trial trenches:

- Currently underway (TH13, 14 and 15) – to complete 30<sup>th</sup> Jan
- Road closure & local traffic diversions
- Parking bay suspensions  $\approx 26$

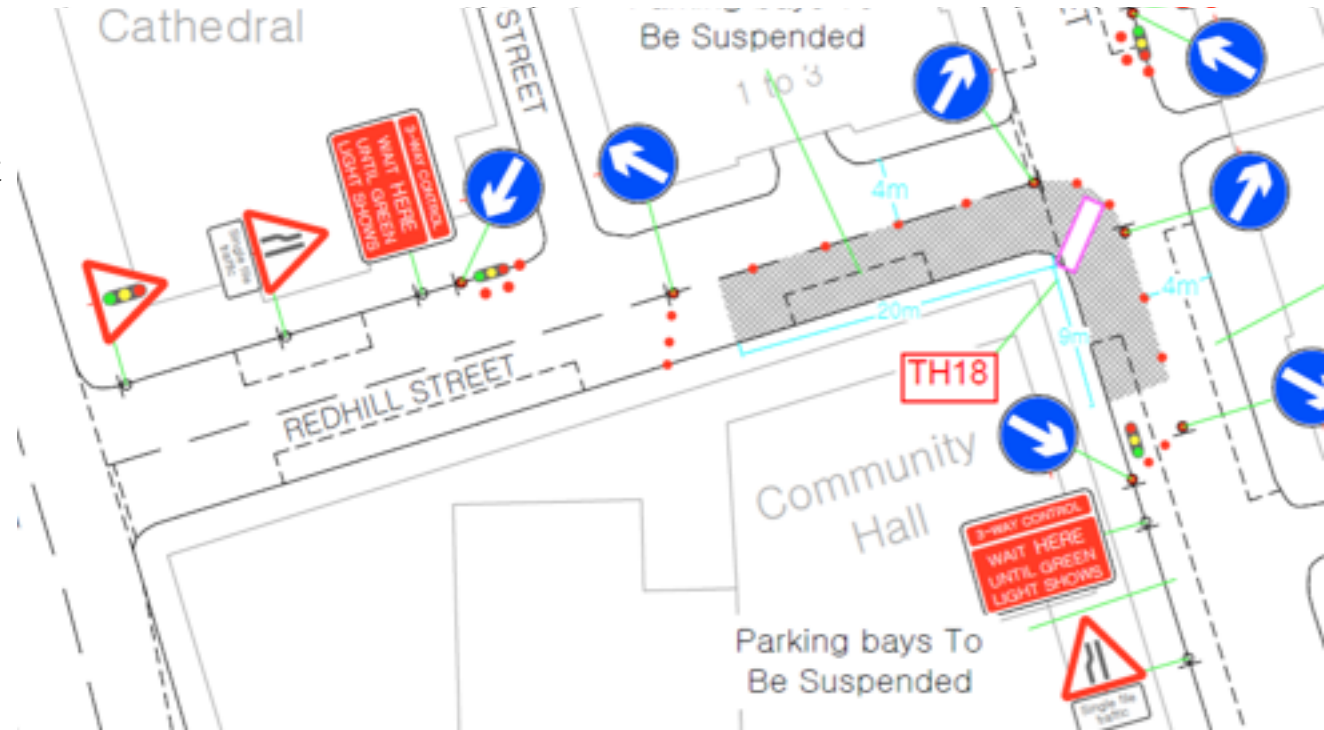




# Area South – Euston Station & Approach – Utilities Works

Redhill Street trial trenches:

- To start 26<sup>th</sup> Jan, complete 9<sup>th</sup> Feb
- Local traffic management
- Parking bay suspensions, approx. 19



## Area South – Euston Station & Approach – Utilities Works

## Albany Street trial trenches:

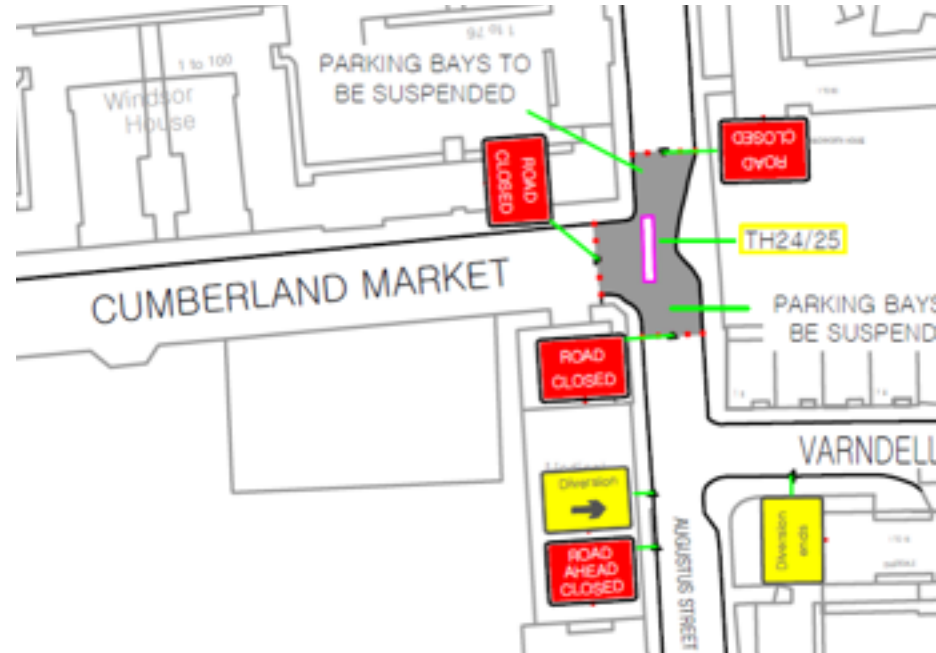
- To start 2<sup>nd</sup> Feb, complete 20<sup>th</sup> Mar
- Local traffic management
- No parking bay suspensions
- TfL will temporarily move a bus stop



# Area South – Euston Station & Approach – Utilities Works

Cumberland Market trial trenches:

- To start 10<sup>th</sup> Feb, complete 24<sup>th</sup> Feb
- Road closure (junc. Augustus St) & local traffic diversions
- Parking bay suspensions, approx. 15-20



# Lorry Route Approval Progress

- Pre-application discussions with the London Borough of Camden from late-2016 onwards.
- Meeting with our Enabling Works Contractor throughout January to discuss their lorry route requirements for early works. Once we have a clearer idea of required lorry routes and numbers then we can have more in-depth discussions with the London Borough of Camden.
- Formal submissions are planned post Royal Assent in early 2017. Provisionally, routes will be as per the Environmental Statement (ES) and any relevant Undertakings and Assurances given.
- Any new or amended lorry routes devised by the contractor that are different to those initially applied for will require additional lorry route approvals.
- Lorry route submissions will include a summary of measures required to ensure the safety and free flow of traffic on the routes, such as vehicle booking system details, driver training, road improvements etc.
- Management of construction traffic and highway issues will be led through the local Traffic Liaison Group (TLG).
