Notice of Works A412 Denham Way/Denham Water Ski Club

High Speed Two (HS2) is the new high speed railway for Britain. Align is working on behalf of High Speed Two (HS2) Ltd to build the new railway in your area which includes the Colne Valley Viaduct. We will need to carry out ground investigation surveys in your area. In order to facilitate these works it will be necessary to carry out some vegetation clearance.

What is happening

Vegetation Clearance

Vegetation clearance to remove a small number of trees with some ground levelling, to enable the ground investigations surveys to take place.

Ground Investigation Surveys

Ground investigation surveys will give us more information about the type, strength and details of the land where the new railway will be built. These ground investigation surveys will help us make sure that the land is suitable for the structures that we want to build.

These works are subject to local authority consent approval.

Load Test Piling

In addition to the ground investigation surveys, our load test piles work continues at the Denham Water Ski Club. Load test piles determine the weight the foundations (piles) of the viaduct can support and will allow us to confirm our design and construction process. These will be conducted on a working platform which provides a stable base for the tests to take place.

Where it is happening

Vegetation clearance will be taking in place along the Rickmansworth Bridleway 004 (shown on the map) from the 19th to the 26th of February.

Ground investigations in this location will take place shortly after. There will be managed access on the Rickmansworth Bridleway 004 for the duration of the ground investigation works.

Load test piling activity is currently taking place at the Denham Water Ski club site.

There will be 3-way traffic lights on the A412 for one day in the middle of March to facilitate long articulated lorries delivering to the site.

Tuesday 19 February to 31 August 2019

Normal working hours will be Monday to Friday 8am to 6pm with Saturday working 8am to 1pm

Our contractors may also be on site for one hour's start up and shut down outside of these times

What to expect

There will be a small increase of Heavy Goods Vehicles (HGVs) on the A412

We do not expect to close any public rights of way

What we will do

Manage any impacts, such as traffic and noise, with the aim of reducing them where we can and take care to respect the community and environment

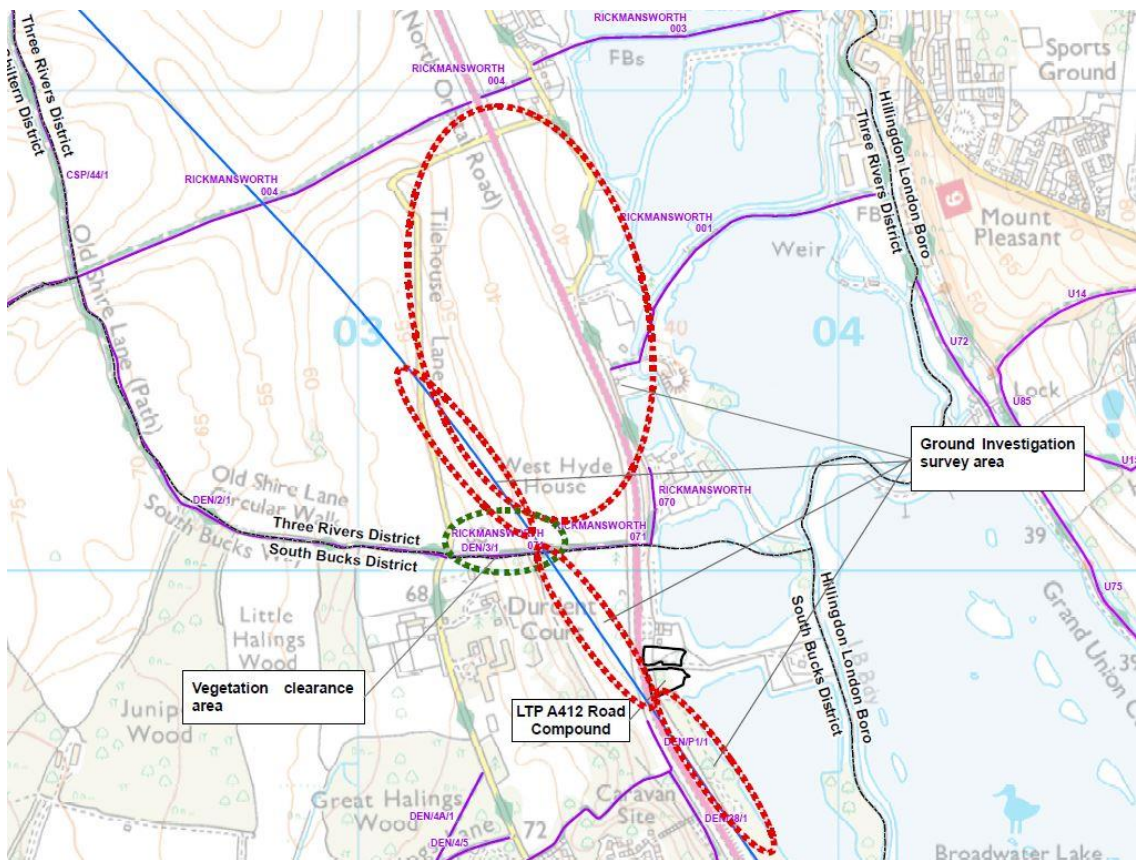
