



## **Notice of works around Great Missenden**

High Speed Two (HS2) is the new high speed railway for Britain.

We are writing to keep you updated on HS2 activities in your local area regarding;

- Archaeological investigations around the location of the temporary haul road;
- Construction of the temporary haul road;
- Relocation of low voltage power lines;
- Widening of the Frith Hill exit onto the A413 roundabout; and
- Widening of Link Rd and the exit on the A413 towards Wendover

## **Archaeological Works**

The investigations into archaeological remains located around the site of the planned haul road are continuing and being carried out by our contractors Infra. They will be digging further trenches to build up a picture of the site below ground and carrying out off-site investigations into discoveries already made. HS2 will share the results of these findings with you once the investigations are completed.

Once these further investigations are carried out we will know when we will be able to start construction of the temporary haul road. For the time being the priority is to learn what we can from the archaeology being carried out on site.

## Construction of the temporary haul road

The earliest we currently expect this to start would be late April/early May. We will be in touch a bit later in the year to report on our progress with the archaeology and when we expect the haul road construction works to start.

In February our contractor Buckingham Group (BGCL) will be setting up a works base for their offices, storage and parking on the site off the A413/Link Rd roundabout.

### **Relocation of UKPN power lines**

UK Power Networks (UKPN) will be starting work on the haul road site in early February to relocate power lines which currently cross the path of the planned haul road. These works will be completed by the end of February. They will be in touch with those who may be impacted specifically by these works.

### Widening of the Frith Hill exit onto the A413

Our contractors BGCL (Buckingham Group Contracting Ltd) will be widening the Frith Hill exit onto the A413 roundabout, creating two lanes coming down the hill onto the roundabout. In mid-February BGCL will carry out some investigations into buried utilities like electricity and cables below ground. These investigations will take approximately one week and will require traffic light controls to protect road users and the workforce.

Throughout the duration of our works described in this letter we will only be placing traffic lights on your local roads between 9.30am and 3.30pm. Lights will be attended by a member of the team to allow the phasing to be modified in line with traffic usage.

Once these investigations are complete lights will be removed for a period with the widening work starting at the beginning of March 2019. This will take approximately 7 weeks to complete.

Our contractor will place advanced notice signage on the road to prepare road users for upcoming works on the highway that could cause traffic delays.

### Widening of Link Road & section of A413

The widening on Link Rd is now expected to begin in late April / early May 2019 depending on the progress of the work on Frith Hill. We will not begin these works until the works on Frith Hill are completed.

As with Frith Hill we will need to carry out some further preparatory investigations into buried utilities before the construction works begin. These are expected to start no sooner than the end of February and will take approximately 2 weeks.



### Widening of Link Road & section of A413 (continued)

The widening of Link Rd and the section of the A413 heading towards Wendover will take us approximately 3 months in total to complete.

We are currently working with the Highways team at Buckinghamshire County Council regarding the preferred method to try to minimise delays to road users while these works are being carried out.
