High Speed Two (HS2) is the new high speed railway for Britain.

We are continuing preparatory works for HS2 in your area. Activities are progressing with the demolition of buildings to the west of Euston Station, works in the Regents Park Estate and extension of the Granby Terrace Bridge to accommodate the new HS2 railway.

Utility diversions and disconnection works at varous locations are also needed in the areas around some sites.

Euston Station and Euston Square Gardens

Works will continue within the station forecourt and the west side of the station. The temporary taxi rank in Euston Square Gardens east is almost complete and will be open to the public in early January.

From January scaffolding will be installed around the two towers at the front of the station, the Grant Thornton Building and One Euston Square, in preparation for demolition.

Euston Street will be closed to pedestrians from mid-December and the pedestrian access via Drummond Street will be widened.

New hoardings will be installed in Drummond Street, Cobourg Street, Euston Street, Melton Street and Stevenson Way. Scaffolds with sheeting will be installed around buildings prior to demolition works starting. It is anticipated that works will continue until late summer 2019.

St James's Gardens and the former National Temperance Hospital site

The work area within St James's Gardens is now enclosed and archaeological excavation is progressing. The tent structure, which is visible from Hampstead Road, is a sustainable scaffold design that will be dismantled and re-used upon the completion of works.

Demolition of the Ibis Hotel will continue through the winter period. Scaffolding will be erected around the Thistle Hotel prior to demolition works starting in January.

The Insull Wing has been taken down to ground level. The footpath on Hampstead Road will be closed from early December for three weeks to dismantle the scaffolding. These works will need a southbound lane closure for two nights.

From early January to early February, we will be digging a trench across Hampstead Road, adjacent to the HS2 offices on the former National Temperance Hospital site to connect permanent power and water supplies to the worksite.

To maintain traffic and pedestrian flow, the work will be carried out in two phases starting on the northbound section of the footway and highway, followed by the southbound footway and highway.

UCL building (previously British Home Stores)

The demolition of this building on Hampstead Road has started and will continue until the spring. From 6 to 21 December, the walkway below the scaffolding will be closed for gas and water disconnection works. Pedestrian signage will be in place to use the opposite footpath.

Regents Park Estate construction site

Once we have possession of the buildings from Camden Council, a site will be established within the Regents Park Estate in preparation for the demolition of Eskdale House, Ainsdale House, Silverdale House, Granby House, Stalbridge House and Old Tenants House on Harrington Street.

In stages, there will be temporary footpath closures, some parking bay suspensions and the bus stop on Hampstead Road will be temporarily relocated southwards while the hoarding is installed.

All utilities will need to be disconnected and fixtures and fittings removed before demolition starts.

Utility works and surveys around Regents Park Estate

From the 10 January to mid-June, UK Power Networks will be carrying out utility diversions on the pavement and in the Eskdale playground area.

Surveys of the services in the roads around the Regents Park Estate will take place from January to March to support UK Power Network diversion works. These surveys will be carried out ahead of the diversion works and follow the planned layout through Stanhope Street, Varndell Street, Harrington Street and Robert Street.

These works will mainly be carried out during the day and will need temporary lane closures with some temporary parking suspensions. Some night works will be likely on Hampstead Road which will include the suspension of the north bound bus lane and the temporary relocation of the bus stop on Hampstead Road southwards. All footpath works will be carried out during day where possible.

Construction traffic routes

When works start in Regents Park Estate, Varndell Street between Hampstead Road and Harrington Street will only be for HS2 traffic access. However emergency services will still be able to use this route at all times and footpaths will remain open.

The parking bays will be suspended and double-yellow lines will be installed on the closed section of Varndell Street and all of Harrington Street.

HS2 construction traffic will also be able to turn left onto Granby Terrace Bridge from Hampstead Road until the bridge extension works start.

Road / footpaths closures in Regents Park Estate for fencing installation

- The footpath and northbound bus lane on Hampstead Road will be closed for two weeks adjacent to Regents Park Estate. The bus stop will be relocated south of its present position
- The footpath opposite Langdale and adjacent to Eskdale playground will be closed for four weeks
- One lane of the road and footpath will be closed on Stanhope Street for two weeks

Lane closures and parking bay suspensions for utility diversion works

- The west bound lane of Varndell Street will be closed between Harrington and Stanhope Street from January to March including 20 parking bay suspensions
- Harrington Street is closed from the north end of the street to south of the junction with Mackworth St. until March. Parking bays will remain suspended



Park Village East

Following a structural assessment, the parapet wall on Park Village East between the existing work site and Mornington Street Bridge needs to be removed.

The works will start in early 2019. Hoarding will be installed, with graphics matching the existing Park Village East hoarding.

In January, further ground investigations works will take place in Park Village East.

Christmas period

The enabling works and Thames Water construction sites will be shut down from 21 December through to 2 January 2019. The HS2 Helpdesk will be in normal operation during this time.

Network Rail will be carrying out works during the Christmas period and the latest information about their works is available at the HS2 in Camden information centre or on the HS2 in Camden website
