

# Stanhope Street and Park Village East works


High Speed Two (HS2) is the new high speed railway for Britain.

We are continuing preparatory works in the area around Euston Station. Activities are progressing to prepare for the extension of the Granby Terrace Bridge to accommodate the new HS2 railway.

## Works on Stanhope Street

Utility diversions and disconnection works will continue to take place on Stanhope Street.

From 7 January to mid-April Stanhope Street between Granby Terrace Bridge and the junction with Varndell Street will be closed. To maintain vehicle access to buildings and minimise parking suspensions the road will be closed in sections:

Sections	Stanhope Street closure locations	Duration
	1. From Granby Terrace Bridge to the area adjacent to the garden opposite Augustus House	3-4 weeks
	2. The section of the road up to the north side entrance of the car park	2 weeks
	3. The section of the road between the second entrance to the car park and the junction with Mackworth Street	2-3 weeks
	4. The section of the road between the junction of Mackworth Street and Mackworth House	3 weeks
	5. The section of the road between Mackworth House and Varndell Street	4 weeks

Traffic diversion signs will be in place and pedestrian access will be provided during these works. Parking bays on closed sections of the road will be suspended and will be returned into use as soon as the works are completed in each section.

The initial breaking of the road surface will be the noisiest activity, although this will be intermittent. We will erect screening with acoustic panels to reduce noise, working as quickly as possible and keep work areas tidy. There will be no disruption to utility services because of these works.

## Works on Park Village East

### DB Cargo shed parapet wall assessment works

We need to carry out a further structural assessment of the remaining section of parapet wall on Park Village East between the existing hoarding and Mornington Street Bridge. To carry out this survey, the foliage will be cleared from the planter to allow access; the trees will not be affected.

This assessment will inform whether the parapet wall is able to remain in place. If the wall needs to be removed, hoarding will be installed with graphics matching the existing Park Village East hoarding. Any decorative stonework that can be retained will be preserved to be used for the reconstruction of the wall in the future.

Temporary fencing will be needed along a section of Mornington Street Bridge and adjacent to the work site, so a traffic lane and part of the pavement will need to be closed. Several parking bays will be suspended while the works are taking place and will be released for use once the works are complete. The area of work is shown on the map below in yellow (■).

We will start these works in early January and complete by early April.

### Ground investigation works on Park Village East

Further ground investigation surveys are planned for January in Park Village East. The results of these surveys will build on the information from previous ground investigations in 2017.

Surveys are planned at five locations between 1 and 48 Park Village East from 16 January for four weeks, taking place at one site at a time to minimise disruption. The work will be on the highway and pedestrian footway on the east side of Park Village East in front of the hoardings. Some partial lane closures, parking bay suspensions and footpath closures will be in place during the works.

We will excavate and drill down into small sections of land to investigate the ground and groundwater conditions. Monitoring equipment will then be installed below a secure cap. In some cases, we will return to monitor these for up to 12 months.

The purple dots (●) on the right map shows the approximate location of the works.

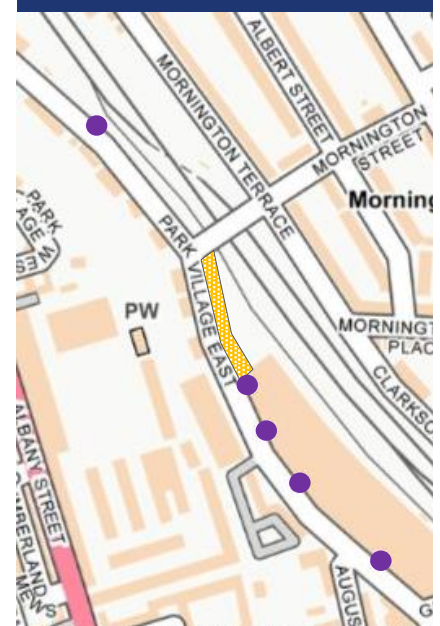
