Utility Works in Robert Street Footway

High Speed Two (HS2) is the new high speed railway for Britain.


We are continuing prepatory works in the area around Euston Station, this includes activities in preparation for the extension of the Granby Terrace Bridge.

We will be conducting utility diversion and disconection works on the north side footway of **Robert Street** between **Stanhope Street** and **Hampstead Road** from **28 January** until mid February. During this period the parking bays on the north side of the street will be suspended.

On **4 February**, in order to undertake these works it will be necessary to close the Robert Street entrance to the car park which serves the Rydal Water, Newby and Derwent buildings for one day. Access to the car park will still be possible via the Varndell Street entrance that is adjacent to Harrington Street.

The initial breaking of the road surface will be the noisiest activity, although this will be intermittent. We will erect acoustic panels to help reduce noise, work as quickly as possible and keeping work areas tidy. There will be no disruption to utility services because of the works.
