Eversholt Street utilities works update

High Speed Two (HS2) is the new high speed railway for Britain. As part of developing the route design of the HS2 high speed railway, we are continuing with preparatory works in the Euston area.

Eversholt Street utilities works

We are working to be a good neighbour every day and following recent events where Thames Water have needed to carry out emergency works on the water main in Eversholt Street, we have been reviewing the approach to our works in the area.

The emergency works have now been completed by Thames Water and the road has reopened.

However the condition of parts of the water main means that we are still concerned about the possible risk of failure from carrying out our works nearby, and the impacts that could have on the community.

Therefore we have agreed with Thames Water that we will bring forward and deliver works to fully protect the water main, before carrying out any of our work on the other utilities in the area.

This will be done by inserting a new main inside the existing main and will ensure the asset will be fully protected for future works in the area.

We are working on plans to reschedule our activities and this means that we will subsequently be starting on site later than previously planned. We will contact you again as soon as we are able to confirm start dates and the arrangements for traffic management. We will continue to keep the road open during this phase of works.

This will not affect our plans for the other utility works in the Euston area.
