Regents Park Estate and Granby Terrace Bridge works

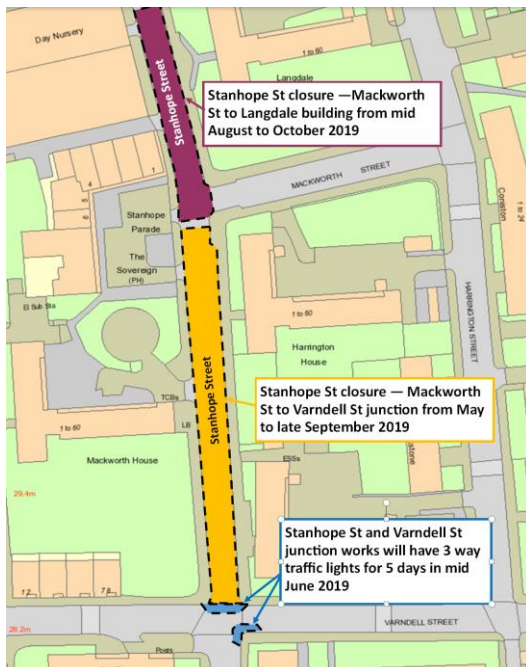

High Speed Two (HS2) is the new high speed railway for Britain. We are continuing preparatory works for HS2 in your area, this includes utility diversion works in the Regents Park Estate and the extension of Granby Terrace Bridge to accommodate the new HS2 railway.

Stanhope Street utility diversion works

We have installed a number of new utility ducts in and around the Regents Park Estate and we are continuing with the remainder along Hampstead Road and **Stanhope Street** towards Varndell Street. During these works we have encountered unforeseen obstructions beneath the road surface and some of the works have taken longer to complete than expected. Therefore we estimate that we will complete our works in Stanhope street during October.

Stanhope Street road closures:

Mackworth Street to Varndell Street from mid-May to late September

Granby Terrace Bridge to Mackworth Street from mid-August to October

Monday to Friday 8am – 6pm, Saturday 8am – 1pm

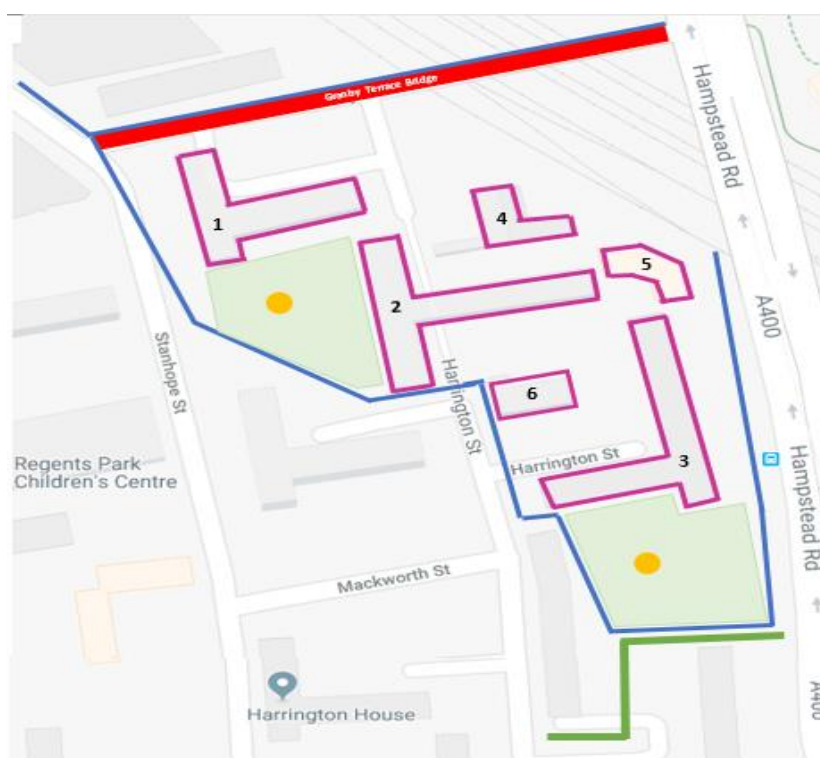

Demolition works at Regents Park Estate

Work is ongoing to prepare for the demolition of the buildings numbered in the map below.

We have started the removal of the internal fixtures and fittings and will begin to remove the external façade material in late June to early July.



A summary of the likely programme and indicative dates for each building are shown in the panel to the right.

More information regarding the demolition works will be presented at the next community drop in event, see details overleaf.

Indicative demolition dates and durations

1. Eskdale – Early August for eight weeks
2. Ainsdale – End June for four weeks
3. Silverdale – Early September for 12 weeks
4. Granby House – Late September for eight weeks
5. Stalbridge House – Early October for eight weeks
6. Old Tenants Hall – Early July for four weeks

UCL building

The demolition of the former UCL building on Hampstead Road is due to finish during June. In the autumn we will begin to demolish the Network Rail Power Signal Box (PSB) which is behind the former UCL building, off Cardington Street.

Granby Terrace Bridge

Between August 2019 and winter 2020, Granby Terrace Bridge will be extended towards Park Village East. This is to accommodate the new High Speed rail lines. Initial activities will take place on the existing bridge, including the removal of the road surface and parapet walls. From August to October we will be demolishing part of the bridge deck. As this work is taking place close to the operational railway, we will need to carry out night time working over six to eight weekends during this period.

Thames Water diversion

Thames Water are continuing their work on the water main diversion with sites at Redhill Street, Robert Street, Albany Street, Gloucester Gate and Park Village East.
