
High Speed Two (HS2) is the new high speed railway for Britain. We are continuing with preparatory works in your area, including utility diversions in Cobourg Street and Euston Street.

What are we doing?

We will be carrying out utility diversions in the southern section of Cobourg Street between Drummond Street and Euston Street. This work will start from 5 August and will take up to five days to complete. The southern side of Cobourg Street will be closed to vehicles and the parking bays will be suspended. Pedestrian access will be maintained and the road will be reopened as soon as possible. Vehicle access will be maintained to Euston Street with the one way system reversed. Vehicle access will also be maintained for Starcross and Drummond Street.

From the 12 – 21 August, works will be taking place across the junction with Drummond Street. Cobourg Street will remain open during this phase but the eastern entrance to Drummond Street will be closed. Access will be maintained for Drummond Street from the west side with two way traffic flows in place. Access for vehicles will be maintained via Starcross Street, Cobourg Street and Euston Street.

From 3-6 September we will be closing the east end of Euston Street. Local access to the Regnart Buildings will be maintained during the works via Cobourg Street. The areas of work are shown below.



Update to crane installation

Due to predicted high winds, the crane installation that was due to take place on Tuesday will now be delayed until conditions improve.

Duration of work

- Southern side of Cobourg Street will be closed from 5-9 August
- Drummond Street eastern access closed from 12 – 21 August
- Euston Street eastern access closed from 3 – 6 September
- Working hours are:
 8am to 6pm Mondays to Fridays, and
 8am to 1pm on Saturdays
- We may be on site for an hour before the start and/or end of each shift

What to expect

- Pedestrian access will be maintained
- Traffic diversions will be in place to maintain vehicle access during each phase of works
- The site will be secured with barriers and acoustic screens to help reduce noise
