# **Notice of Thames Water Works**

High Speed Two (HS2) is the new high speed railway for Britain.

HS2 Ltd and Thames Water are moving the 42" water main from Park Village East in preparation for the construction of the railway. The water main will be diverted through the Regents Park / London Zoo car park, Albany Street, Redhill Street and Cumberland Market.

#### **Your Thames Water update**

We are progressing well with our work in the area and will be starting work at new locations such as Robert Street as well as continuing to be onsite at our existing work areas.

#### Where we are working

In September, we are moving on to phase two of our work in **Cumberland Market** which will include weekend works. We will keep noise and disruption to a minimum and there may be times where we do not need to work. Augustus Street will be partially re-opened.

We have moved further north on **Albany Street** to work outside the Barracks. Due to the location of our work we are required to work weekends. **Redhill Street** is now open at both ends.

We will be starting on our first phase of work at **Robert Street** to lay new water pipes. This will take place on the section of road between **Stanhope Street** and **Hampstead Road** from early September. There will be a road closure and diversion in place.

The northern end of **Park Village East** has been closed to carry out some trial holes. We have several phases of work to carry out in this area and our work will be completed early 2020.

#### How you are affected

The road closure and parking restrictions will continue at **Cumberland** Market. Please see on-street signage for parking suspensions and diversions. Footpath access will always be maintained to and from properties.

There will continue to be temporary traffic lights in place on **Albany Street** to maintain two-way traffic. A road closure is in place at the northern end of **Park Village East**. The diversion route is via **Albany Street** and is clearly signposted.

#### **Duration of work**

- **Albany Street** between the Barracks and **Gloucester Gate** due to complete in early 2019
- Park Village East will fully reopen early 2020

# **Hours of working**

- Our core working hours are 8am to 6pm, Monday to Friday and 8am to 1pm on Saturdays
- **Cumberland Market** and Albany Street weekend working hours are; Saturday 8am – 6pm and Sunday 9am - 5pm

#### What to expect

- Road & footpath closure on **Cumberland Market** by the Medical Centre
- Road closure on **Robert** Street between Stanhope Street and **Hampstead Road**
- Road closure of the northern end of **Park** Village East
- Bus stop on **Albany Street**, near the junction with Redhill Street remains suspended
- Rolling, single lane closure on Albany Street
