Works between Euston Station & Primrose Hill tunnels - 1 April to 1 July

Further to our letter of 1 February, I am writing to provide an update on our ongoing planned work near to your property. This letter sets out our activities until 1 July based on the present programme. Appendix A & B below provide more details on where and when work is expected to take place.

What are we doing?

Network Rail and their contractors will continue to prepare the way for building Britain's new High Speed 2 (HS2) railway. In addition to this, some non-intrusive survey works also need to be carried out during the periods when the railway is not in operation. We do not expect these surveys to have any significant noise impacts.

Community drop-in

We are also attending a joint community drop-in event with HS2 Ltd on 23 May where the details of these works will be shared and staff will be able to answer questions about the works. This event will be held between 5pm and 7pm at:

HS2 enabling works - undertrack crossings (UTX's)

Further work is scheduled to take place on the UTX's during weekend night and morning possessions over the next two or three months. Measures will be in place to ensure as little disturbance as possible is caused.

HS2 enabling works – overhead line works etc.

During the next three months, a variety of works will be taking place throughout the Camden Cutting between the station and the Primrose Hill tunnels. This will include drainage works, refurbishing of the Camden carriage sidings in areas D & E, and works to upgrade the overhead power lines. Engineering trains will deliver materials and equipment and take away waste.

The foundations for the overhead line works will be built using piling which will be vibrated into the ground and then a "hammer" will be used to ensure they are at the correct depth. Vibration piling will be used during the nights and early mornings and the hammer will only be used during daytime hours from 7am. This method of piling has been used successfully before and, where it is safe to install, noise barriers will be used.



HS2 enabling works - new electrical substation

Works are continuing at our Barnby Street site for the construction of a new electrical substation that will assist in powering London Euston Station. There will also be some noise generated from general building works such as cutting steel and wood using power tools, as well as some concrete breaking where it is needed. Noise monitoring is in place to ensure that any potential disturbance is kept within agreed limits. Deliveries of materials and collections of waste from the site will continue. In order for the overall works to be completed prior to the critical date of the Christmas 2018 possession, the contractor is requesting an extension of the consented Saturday working hours: 08:00 hrs to 17:00 hrs rather than the current 08:00 hrs to 13:00 hrs.

Why do we need to undertake the work?

Network Rail is carrying out these works to both maintain and improve the existing operational railway, and to prepare the way for HS2 in the Euston area.

To guarantee safety, much of this work must be carried out while trains are not running and when the overhead power line is isolated. Network Rail is contractually obliged to work whenever possible at times that cause the least disruption to train services. Unfortunately, this often means carrying out improvements mid-week between 08:00 and 18:00, during weekday night-time possessions between 21:00 and 6:45 and at weekends between 18:00 Saturday to 06:45 on the following Monday.

To reduce disruption, we have scheduled these works with railway maintenance work at Euston. It is possible that as a result of operational needs or incidents beyond our control, work may be cancelled, rescheduled or carried out in a different area, at short notice. Non-scheduled maintenance or emergency works may also take place during hours when there are no rail services.

How will this affect me and will this be noisy?

Network Rail is working closely with Camden Council to reduce the impact of these works. All works carried out by Network Rail relating to HS2 enabling works have been agreed with HS2 Ltd and Camden Council, and will comply with Section 61 of the Control of Pollution Act 1974, which places restrictions on noisy works.

Unnecessary noise will be reduced where possible through the use of noise barriers, silenced generators, and continuous noise monitoring. For safety reasons it is not always possible to provide acoustic noise barriers when work at height is taking place or works trains and track mounted vehicles are moving within the work area where safety warnings such as train horns and vehicle alarms are mandatory.

Temporary lighting is also needed to give adequate and safe lighting levels for staff working at night and during overcast weather conditions. Staff members have been briefed to ensure that where possible and it is safe to do so, this does not cause unnecessary light intrusion into lineside residential properties.

There may be a number of different tasks taking place concurrently, carried out by different contractors. All staff and contractors are regularly briefed on working responsibly in the local community, regardless of the purpose of the work being carried out. However, should you have any complaints, observations or queries regarding the works taking place, it would assist us to be provided with any company identification, which may be visible on operative's work wear or vehicles. This will enable a more timely investigation and resolution.



Who should I contact if I have further queries?


