Our work

We are still working hard to reconnect part of the 42" water main to the new pipe on Albany Street. To do this we will need to work two weekends set out in the panel to the right. Our working hours will be; **Saturday 8am – 6pm and Sunday 9am – 5pm.**

Your water and waste services should not be affected.

- We will be working the following weekends; 1 -2 September and 8 - 9 September
- Weekend working hours; Saturday 8am – 6pm and Sunday 9am – 5pm
