

Ground investigation works on King Henry's Road

High Speed Two (HS2) is the new high speed railway for Britain.

As part of developing the route design of the HS2 high-speed railway, we are carrying out further ground investigation works in your area. The results will build on the information we already have from the work done in 2017, helping us get a better understanding of the ground and underground building foundations.

What are we doing?

A ground investigation survey is planned in the driveway at 6 King Henry's Road, between the period 7 January to 25 January and it will take approximately three weeks. We will dig and drill down into small sections of land to investigate the ground and the underground building foundations. The approximate location of the survey is shown below.



How will this affect you?

We will temporarily suspend four parking bays next to the entrance to 6 King Henry's Road to accommodate our site welfare unit. There will be some noise during the hours listed in the panel to the right; the site will be surrounded by protective barriers and acoustic screens to reduce this.

Duration of work

- Three weeks between 7-25 January
- Working hours are from 8am to 6pm Mondays to Fridays and Saturdays from 8am to 1pm if needed
- We may also be on site for an hour before the start and/or end of each shift

What to expect

- Drilling machines and mobile units on site
- Some noise during the times above
- Site secured with barriers and acoustic screens to help reduce noise
- Pedestrian and vehicle access will be maintained at all times.
- A generator might need to run for a period during these works
