## **Update: Notice of ground investigations near Adelaide Road trackside**


High Speed Two (HS2) is the new high speed railway for Britain. As part of developing the design of the HS2 high-speed railway, we are carrying out further ground investigation in your area.

## What we are doing

We will carry out ground investigations next to the rail tracks, behind the embankment on Adelaide Road. This will involve using drills and other equipment to examine the ground conditions. This information will help us design and construct the HS2 tunnels in this area.

The ground investigations will take place from 5 September for up to four weeks.

We will not be working in Adelaide Local Nature Reserve. Our staff will walk through the nature reserve to access the worksite.



#### How this will affect you

During these works we will suspend five parking bays on Fellows Road, near the junction with Eton Road. This is to provide staff welfare facilities.
