## Update: Further ground investigations on Park Village East and Parkway

High Speed Two (HS2) is the new high speed railway for Britain.

As part of developing the route design of the HS2 high-speed railway, we are carrying out further ground investigations in your area. The results will build on the information we have from recent investigations as well as work done in 2017, helping us get a better understanding of the ground conditions and underground building foundations

### Ground investigations planned in your area

Further ground investigations are planned on Park Village East and Parkway from 12 August for up to four weeks.

The approximate locations of the works are shown on the map below.



### Duration of works

From week starting 12 August for up to four weeks

Working hours:  
Mondays to Fridays,  
8am to 6pm and  
Saturdays 8am to  
1pm (if needed)

We may be on site for an hour before the start and at the end of each shift

### What to expect

Sites secured with acoustic barriers to reduce noise

Drilling equipment and mobile units on site

A generator may be used during the works

### What are we doing on Park Village East?

Ground investigations will be carried out opposite 10 – 16 Park Village East.

A partial lane suspension will be in place at the north end of Park Village East. Local access to properties will be possible at all times but parking bays outside 10 – 16 Park Village East will be temporarily suspended during these works.

The footway on the railway side of Park Village East will be temporarily closed. Pedestrians will be diverted to the footway on the other side.

The Thames Water worksite on the northern end of Park Village East will remain in place during these works.

### What are we doing on Parkway?

We will be working in the footway outside North Bridge House Preparatory School during the summer school holidays. The footway width will be restricted during these works, but pedestrian access be maintained at all times.

We always do our best to reduce our impact on the community and where possible, undertake works near schools in the school holidays.
