

Update: ground investigation surveys on Park Village East

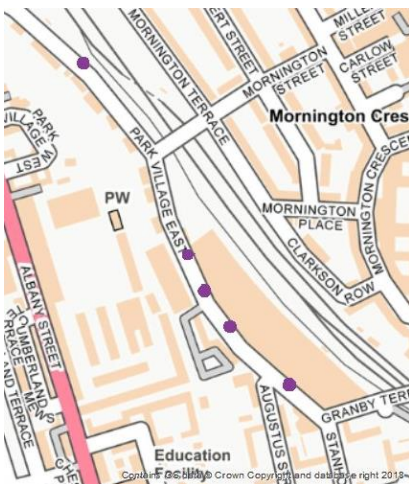

High Speed Two (HS2) is the new high speed railway for Britain. As part of developing the route design of the HS2 high-speed railway, we are carrying out further ground investigation works in your area. The results will build on the information we already have from work done in 2017, helping us get a better understanding of the ground conditions and underground building foundations.

What are we doing?

Due to unforeseen circumstances, ground investigation surveys along Park Village East could not start from mid-January as planned. Subject to approvals, the ground investigation surveys are now planned from the week starting 18 February for up to four weeks. As before, the surveys are planned at five locations between 1 and 48 Park Village East, taking place at one site at a time to minimise disruption.

How will this affect you?

The work will be on the highway and pedestrian footway on the east side of Park Village East, in front of the hoardings; temporary changes are listed in the panel to the right. Duration of work

- From the week starting 18 February for up to four weeks
- Between 08:00 and 18:00 on Mondays to Fridays
- Between 08:00 and 13:00 on Saturdays if needed
- We may be on site for an hour before the start and/or end of each shift
- As part of testing activity, the generator might need to run for a period during these works

What to expect

- Work will take place on the highway and pedestrian footway on the east side of Park Village East
- Partial lane suspensions and footpath closures will be in place during the works
- Sites secured with barriers and acoustic screens to reduce noise
- Drilling rigs and mobile welfare units to support the activity
