Update - ground investigation work on King Henry's Road





High Speed Two (HS2) is the new high speed railway for Britain.

As part of developing the route design of the HS2 high-speed railway, we are carrying out further ground investigation works in your area. The results will build on the information we already have from the work done in 2017, helping us get a better understanding of the ground and underground building foundations.

What are we doing?

Due to unforeseen circumstances, the ground investigation work near 6 King Henry's Road will continue until 8 February. We will dig and drill down into small sections of land to investigate the ground and the underground building foundations. The work will continue in the approximate area shown below.



How will this affect you?

Four parking bays will remain suspended near 6 King Henry's Road to accommodate our site welfare unit until the works are completed. There will be some noise during the hours listed in the panel to the right; the site will be surrounded by protective barriers and acoustic screens to reduce this.

Duration of work

- Work will continue until 8 February
- Working hours are from 8am to 6pm Mondays to Fridays and Saturdays from 8am to 1pm if needed
- We may also be on site for an hour before the start and/or end of each shift

What to expect

- Drilling machines and mobile units on site
- Site secured with barriers and acoustic screens to help reduce noise
- Pedestrian and vehicle access will be maintained at all times
- A generator might need to run for a period during these works
