## Surveys and investigations beneath track level

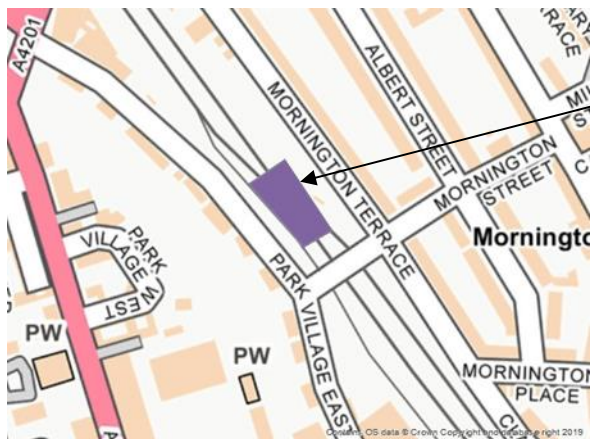
High Speed Two (HS2) is the new high speed railway for Britain. As part of developing the route design of the HS2 high-speed railway, we are carrying out further surveys and investigations of the structures at track level.

### Surveys and investigations beneath track level north of Mornington Street Bridge

We will be carrying out survey and investigations work below the Network Rail track level area just north of Mornington Street Bridge from 11pm on the 5 October to 11pm on the 6 October 2019.

We will be surveying the structure which supports the tracks in this area and this will include taking core samples from the bridge structures from beneath the track level.

This work is co-ordinated with the Network Rail preparatory works and will be taking place during this period when the trains are not operating. Equipment will be delivered to site at track level and measures will be in place to reduce noise where possible. The approximate location of the works is shown on the map below.

#### Duration of works

Overnight from 5 to 6 October 2019

Working hours: Saturday 11pm to Sunday 11pm

The works will take place overnight during rail engineering hours, when trains are not running

#### What to expect

Handheld drilling equipment and a generator will be used trackside

On site noise monitoring will be carried out
