Notice of Thames Water work at Gloucester Gate

High Speed Two (HS2) is the new high speed railway for Britain.

Gloucester Gate

We will soon be carrying out works at the intersection of Gloucester Gate and Albany Street. This is to lay new pipes as part of the water main diversion being undertaken. Our work will be carried out in two phases and will be completed by March 2019. There will be a full road closure in place between the junction of Outer Circle and the junction of Albany Street for the duration of the works.

Our work

Phase one

In addition to the full road closure on Gloucester gate, the northbound lane on Albany Street will be closed. There will be two way traffic lights in place so that access to and from Albany Street will be maintained at all times.

Work will start on Monday 29 October and we will complete this section of work by mid-December. We will be working Monday to Friday and we may also work on Saturday and Sunday when required. Our working hours are in the panel on the right.

Phase two

This will take place within the road closure on Gloucester Gate and both lanes of Albany Street will remain open during this phase.

The **diversion route** for the duration of our work will direct traffic around Regents Park from Albany Street to Hanover Gate.

Your water and waste services should not be affected while we carry out this work.

Duration of work

- We will be working in Gloucester Gate from October to March 2019
- Our core working hours are: Monday – Friday 8am to 6pm; Saturday 9am to 1pm
- Weekend working hours Saturday 8am – 6pm; Sunday 9am - 5pm

What to expect

- There will be some increase in noise levels
- Parking / dropping off on Gloucester Gate will not be possible
- Footpaths will remain open but there may be a diversion in place

What we will do

- There will be a marked road diversion in place
- Acoustic barriers will be in place
- There will be no disruption to your water or waste services as a result of our works
