

Notice of Road Closure of Breakspear Road South

To allow construction of the High Speed Two (HS2) railway, Affinity Water need to carry out some work in your area. This means that we need to close Breakspear Road South between the Chiltern Line railway bridge to the junction of Breakspear Road South and Copthall Road West between 21 July and 11 August 2018.

Why are we closing it

We need to move an underground water pipeline. The pipeline is an important supply of water for north west London and Watford area and this diversion is needed to continue to ensure a safe and reliable supply to the area. The road closure is needed to allow us to carry out the works as quickly and as safely as possible.

What work is being carried out

Affinity Water's contractors, Barhale, will install a new pipeline on farm land south of the Chiltern Mainline across Breakspear Road South, tunnel under the Chiltern Line and connect the new pipeline east of Affinity Water's existing pumping station. Most of the work will involve open cut trenches with a bored underground tunnel underneath the Chiltern Line. We will also need to install temporary haul roads to allow Barhale to access the area and create works compounds for storage and staff facilities.

How will this affect you

We will put road diversions in place and we urge you to find alternative routes for your journeys.

The work will take place Monday to Saturday 8am to 6pm and Sundays 8am to 1pm. There will also be site activities, such as health and safety briefing and deliveries, happening for an hour either side of these times. However, these won't involve operating any machinery that might cause a disturbance to you.

To complete boring the tunnel, we will need to work 24 hours a day. This work is not expected to take place until later in the summer. As the work is underground we do not expect any noise or disruption.

Duration of work

- Monday to Saturday 8am to 6pm and Sundays 8am to 1pm
- The closure of Breakspear Road South will be from 21 July to 11 August
- The work for laying all of the pipeline will finish in August 2019

What to expect

- Heavy Goods Vehicles will be onsite as well as operating to and from site
- Footpath U84 will remain open but be re-routed
- Footpath U51 will close but an agreed footpath diversion will be put into place with signage from Copthall Road West and Brackenbury Farm entrance on Breakspear Road south.


What we will do

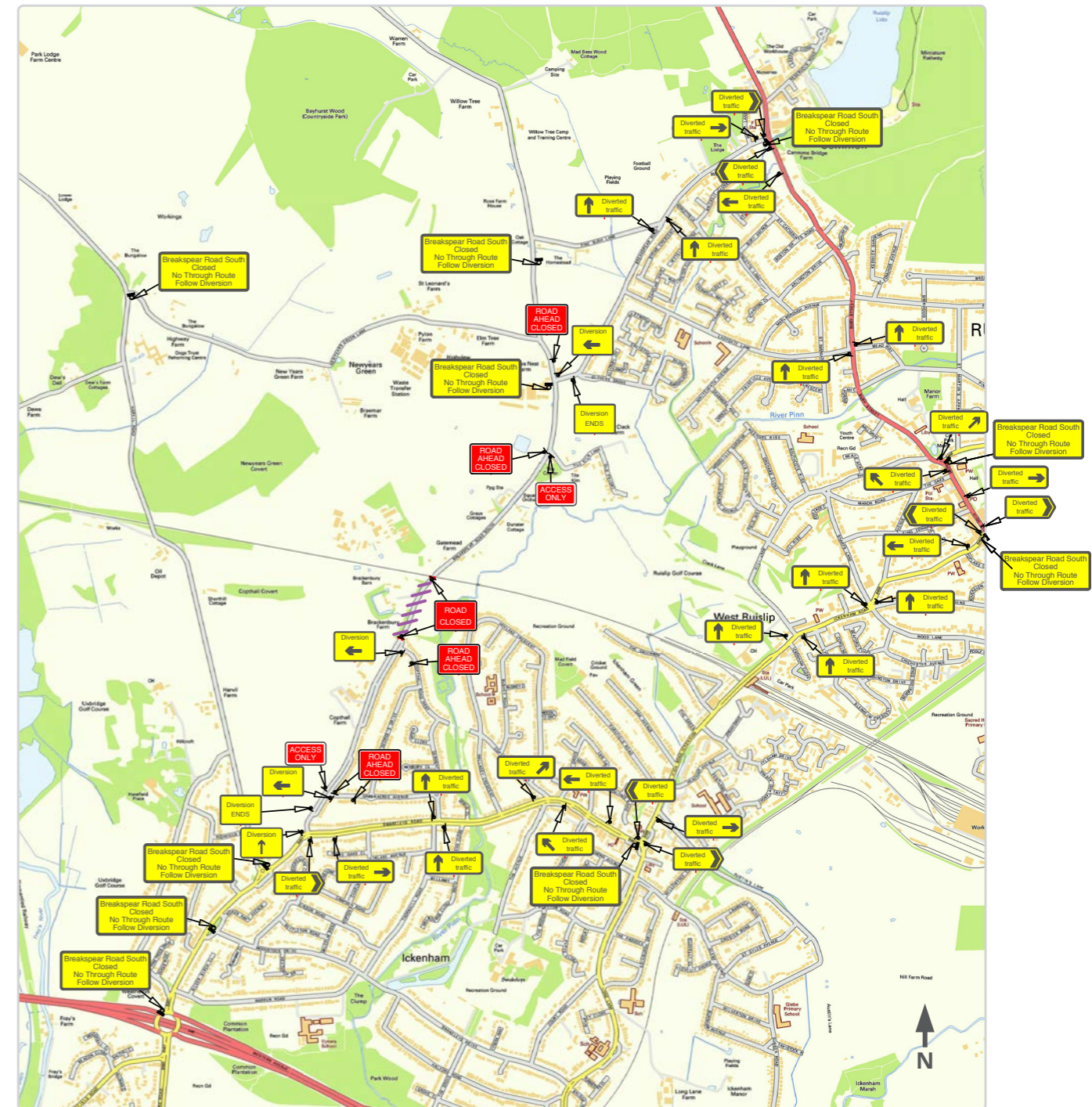
- Manage traffic and noise

Road diversions in Ickenham and Ruislip

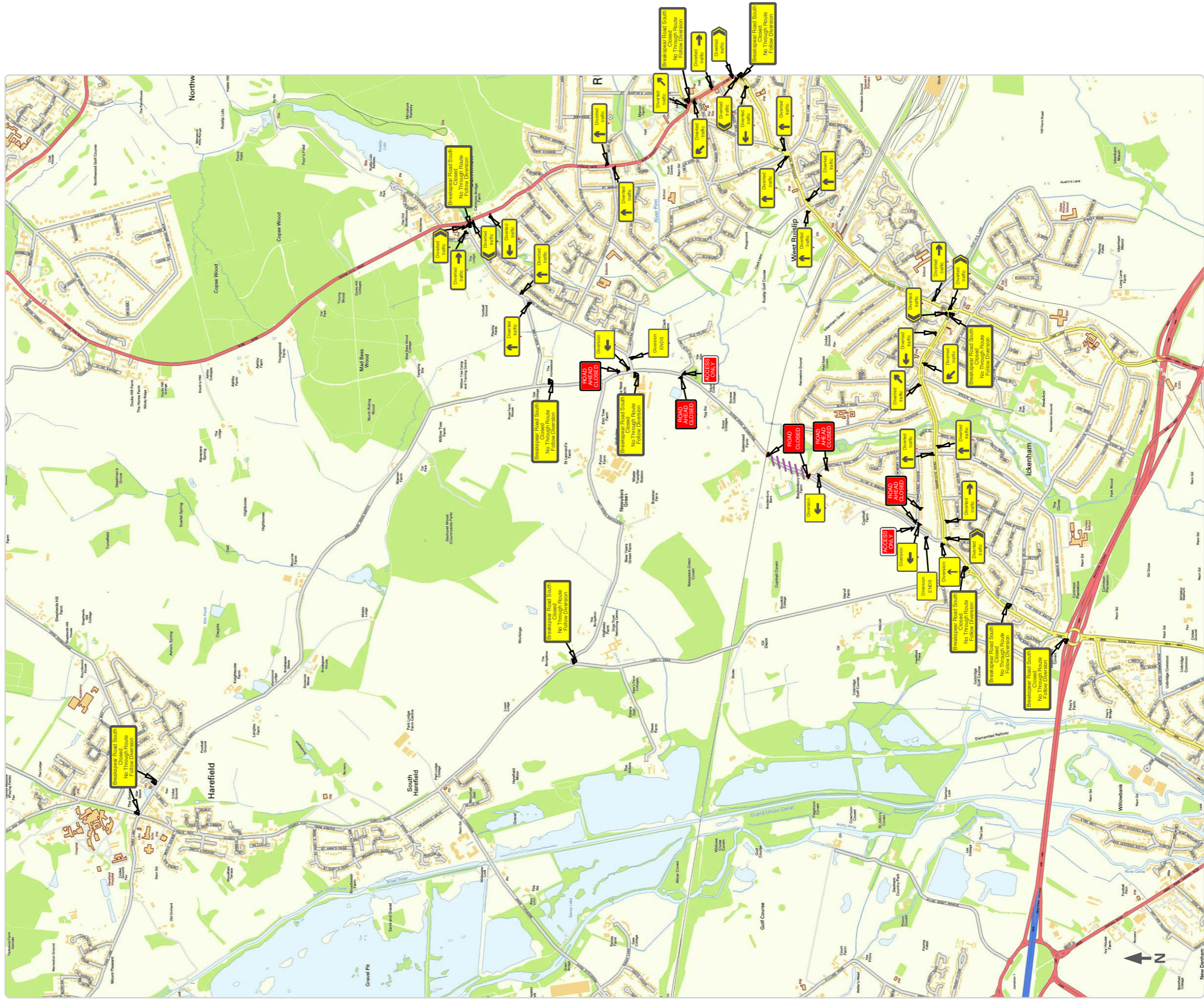

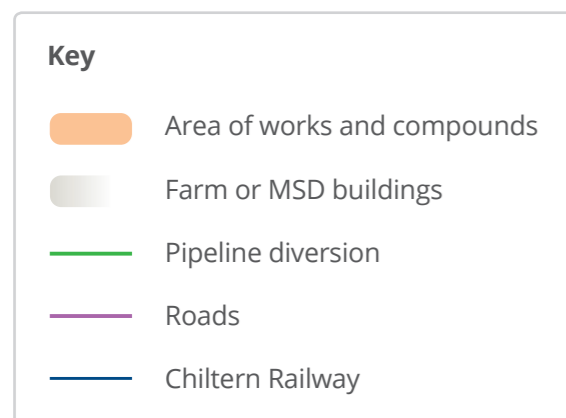
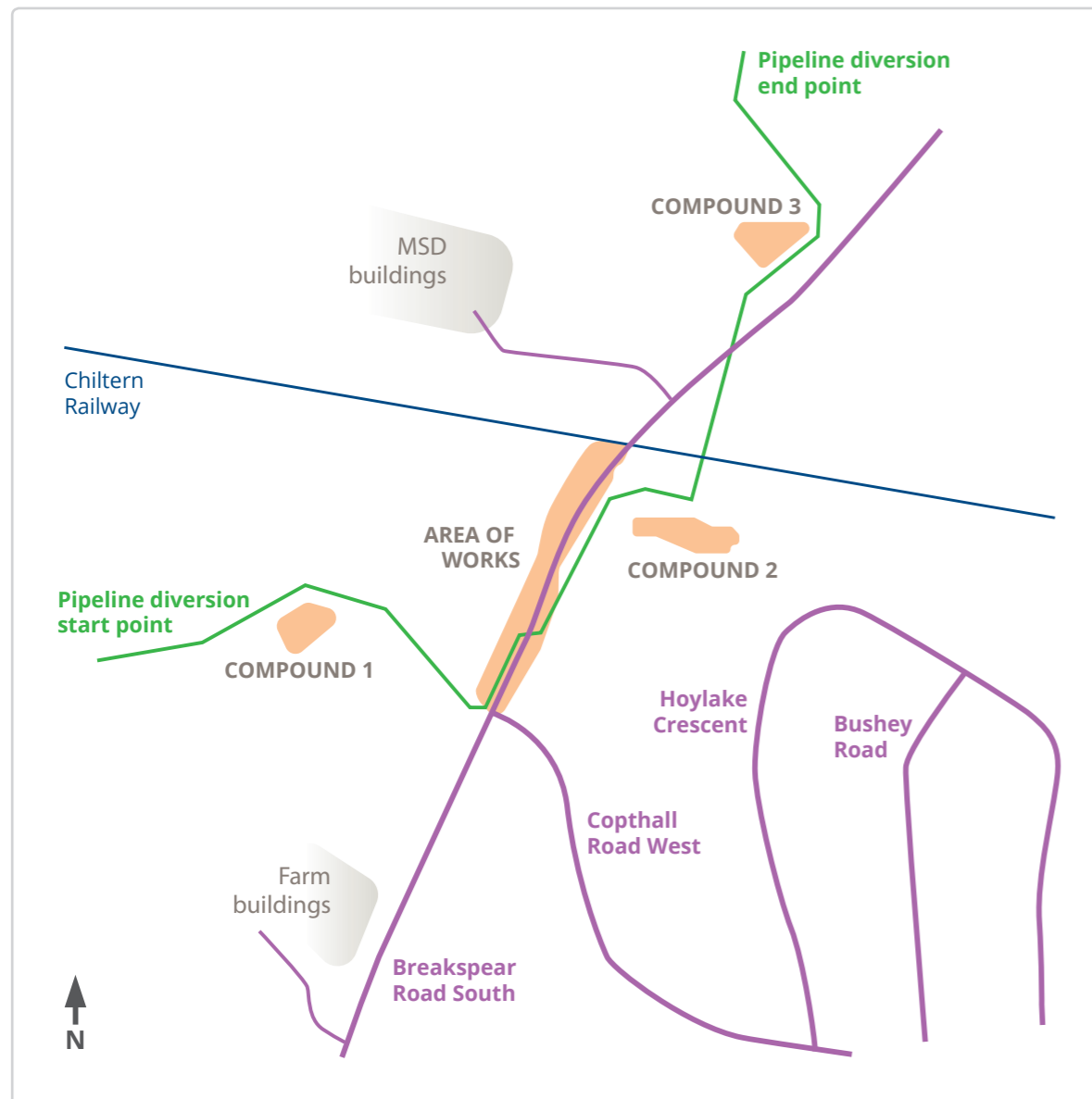
 Area of works
