# **Update of road closure on Breakspear Road South**

High Speed Two (HS2) is the new high speed railway for Britain. As part of the construction, Costain Skanska Joint Venture (CSJV) are continuing the preparatory works on behalf of HS2 Ltd within the Hillingdon area.

## **Update of closure extended to Friday 16 November**

During the excavation of Breakspear Road South it was discovered that the existing water mains is not configured in the way that the historical information suggested it was. Also, due to its poor condition we were forced to change our excavation method and the existing pipework's joint is corroded and showing signs of weakness.

In order to complete the works safely, some adaptations to the design are being made and new parts are required. As a result of these changes, we require more time to complete the works.

#### How will this affect me?

Access will be maintained to properties north of the Merck, Sharpe and Dohme site and access only signs will be displayed along with operatives being present 24 hours a day.

Advance warning signs will still be place alerting road users that there is no through road. Please note pedestrians will be unaffected from these works, as there is no footway.

Some traffic congestion should be expected.

#### **Duration of work**

- Breakspear Road South works extended until
   Friday 16 November
- Working hours: Monday to Friday 24 hours a day
- Saturday 8am to 5pm
- Staff may be on site for half an hour before the start and/or at the end of each shift

#### What to expect

- Breakspear South Road will be accessible only for residents, farm and site works
- Traffic management signs will be in operation 24 hours a day

#### What we will do

- Inform you of any changes to these dates
- Keep all site safe and secure








