

Notice of upcoming works at Ruislip Golf Course

High Speed Two (HS2) is the new high speed railway for Britain. As part of the construction, Costain Skanska Joint Venture (CSJV) are continuing the preparatory works on behalf of HS2 Ltd within the Ruislip Golf Course site.

Preparatory Works

The works will take place in phases as shown in the map on page two. This notice is about Phase 1A which will take place over a period of five to six weeks between 24 September and 31 October.

Phase 1A will involve:

- The installation of temporary wire fencing
- Site mobilisation including installing some cabins
- Vegetation clearance
- Creating a new site entrance and exit
- Soil removal and building a new access road
- Installing solid hoarding to replace the temporary fence.

What else will be happening?

Several great crested newts have been found in a pond to the far west of Ruislip Golf Course and will be relocated to the new habitat that has been created on the Merck Sharpe and Doehme land, off Breakspear Road South. A newt fence and barrier will surround the area where they are most likely to be found.

The clearance of small strips of scrub vegetation is due to take place within the golf course. The strips will be approximately 1 metre wide and consist mainly of brambles. This is to allow the installation of newt fencing to protect the newts from harm during future works. No trees or hedgerows will be removed during this phase of clearance work.

How will this affect me?

From the 24 September 2018 new two metre high wire fencing panels will be installed along phase 1A to secure the new construction site and prevent public entry. This will be replaced by solid hoarding after four to six weeks.


A pickup van and lorry loader will be used to get tools and materials to and from site. There will be no more than 24 vehicle movements a day.
