Notice of road closure on Newyears Green Lane

High Speed Two (HS2) is the new high speed railway for Britain. As part of the railway's construction we are continuing preparatory works within Hillingdon.

Between now and June 2019 we will be carrying out environmental work in the area, to help inform our future construction works.

Newyears Green Lane closure

As part of our archaeological works, we need to close a section of the road on Newyears Green Lane. The closure is required in order to gain access to land adjacent to the BFA Recycling Centre. Our works are to secure our site entrance, delivery equipment to enable us to undertake archaeology works within Newyears Green field. These works are not anticipated to be noisy.

We will install advanced notification signage two weeks before works commence. Access only signs will be displayed, with operatives present during working hours. Access will be maintained to all properties and businesses on Newyears Green Lane.

We recognise that the closure will affect both the travelling public and the local community, and we are therefore taking all possible steps to minimise disruption and inconvenience, undertaking this closure on weekends.

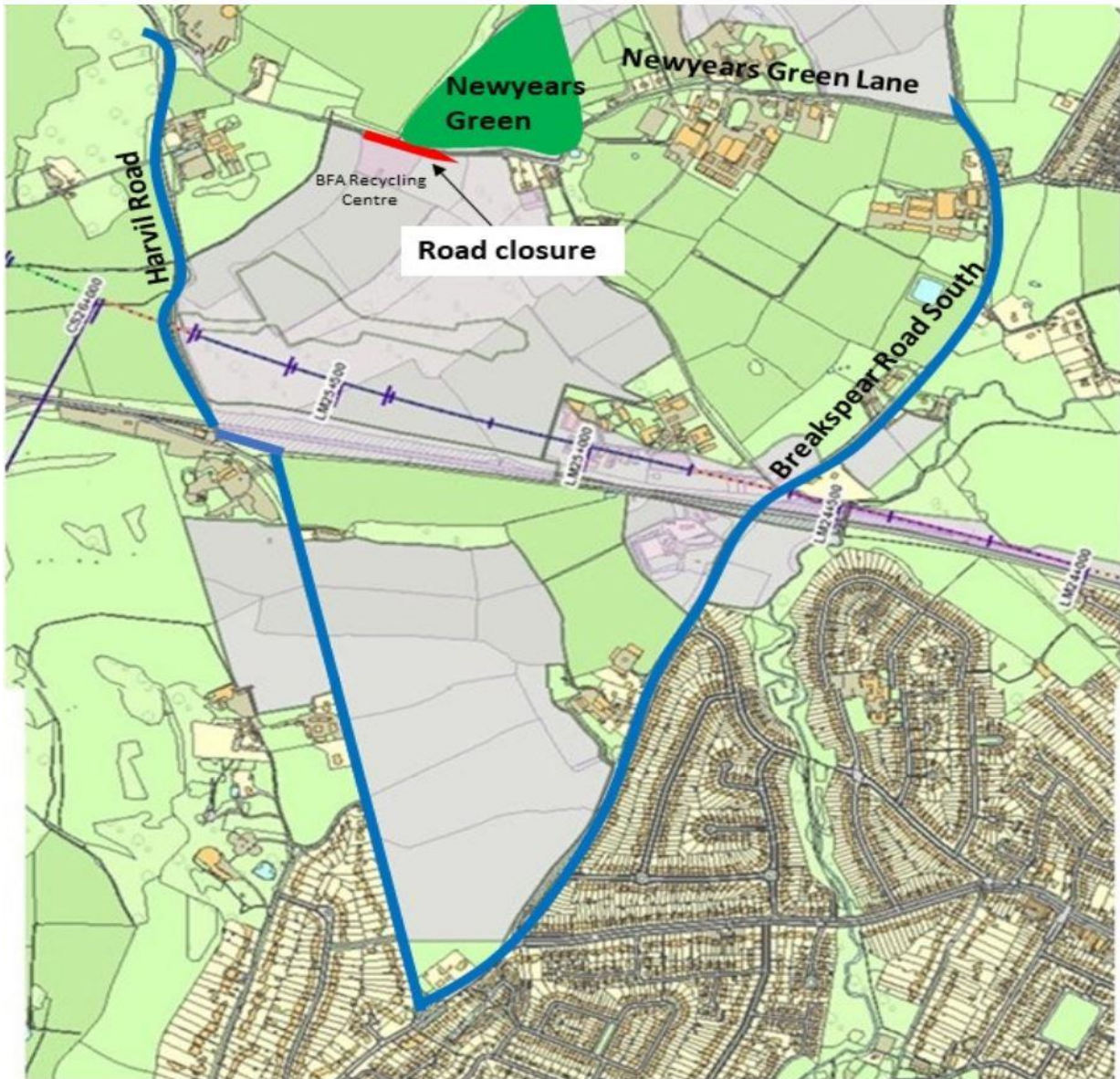
