



UPDATE ON UTILITY DIVERSION WORKS: ARCHAEOLOGICAL TRIAL TRENCHES

What are we doing?

Prior to utilities diversion work within the London Borough of Hillingdon, a number of activities will take place at two locations; to the east and the west of Harvil Road (please see map overleaf) which includes archaeological trial trenching and mitigation. This work will be carried out by a Chartered Institute for Archaeologists (CIfA) registered Archaeological Contractor and will comprise a phase of trial trenching to identify areas of archaeological potential.

The archaeological trench surveys will be carried out on **Harvil Road** the week commencing **29 January** and it is anticipated that the works will last for a duration of three weeks.

How will this affect me?

There will be a small number of HGV movements on local roads, particularly during site set up and site completion.

Additionally, as part of the above planned works, the public right of way (PRoW), footpath U34 that runs between Dews Lane and Harvil Road will be closed temporarily for a period of approximately two weeks, due to commence end of January/early February. The need for this temporary closure is to allow for the above activities to take place safely and securely. There will be diversion signs in place to indicate an alternative route. We apologise for any inconvenience this may cause.

There will be no need for traffic management during these works.

We recognise that construction work can be disruptive to those living or working nearby. The nature of our work often means some disturbance is unavoidable, but please be assured that every effort is made to minimise any unnecessary disruption and we have reminded all staff and contractors to be considerate of the environment they are working in.

Working hours

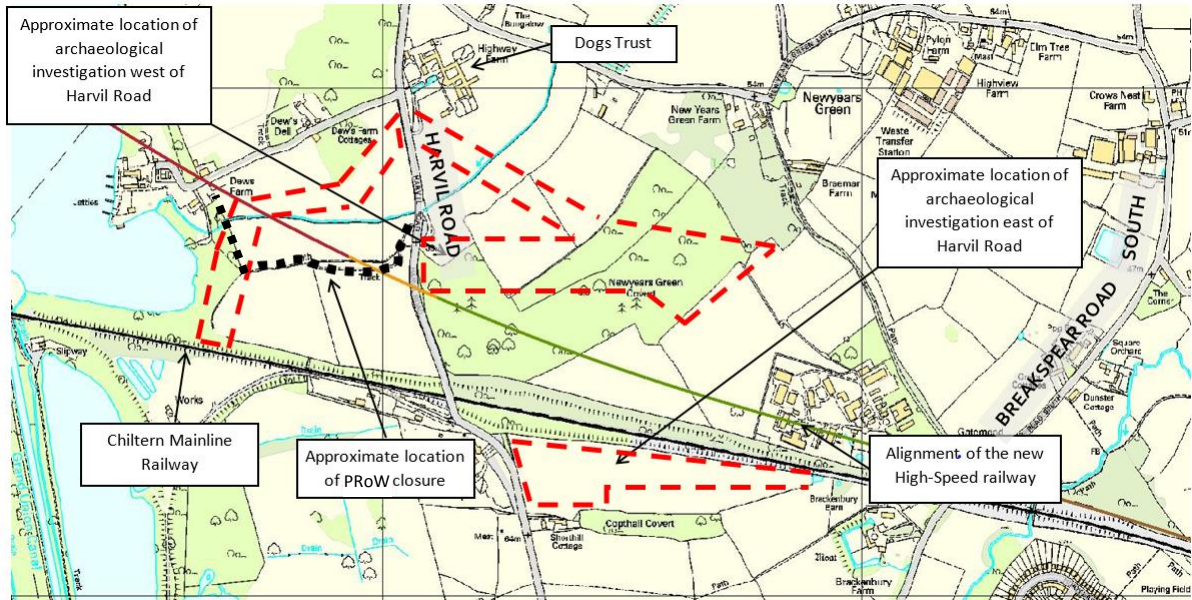
- Weekday working hours: Monday to Friday 8am-6pm
- Our contractors may also be on site for one hour's start-up and shutdown.

What to expect

- Herras fencing installed around the perimeter of the site.
- A small number of HGV movements on local roads, especially for site set up and once the work finishes.
- No traffic management is required on local roads, however, the bridleway off Dews Lane will need to be temporarily closed.

What we will do

- Inform you in advance of any changes to the dates shown.
- Keep all sites safe and secure.
- Ensure that all sites are reinstated to the required standard.
