Reminder: road closure, Harvil Road

High Speed Two (HS2) is the new high speed railway for Britain. As part of the railway's construction we are continuing preparatory works within Hillingdon.

Road closure for vegetation clearance works on Harvil Road

We will be undertaking vegetation clearance work around Harvil Road on Saturday 27 April and Sunday 28 April. As we are removing some trees as well as low level scrub, this work requires a road closure. Harvil Road will be closed to the areas on the north and south of the current Cadent Gas site on the east of Harvil Road shown on the map below.

The road will remain closed throughout from Saturday 27 April to Sunday 28 April. Ecological surveys have been undertaken and an ecologist will be on site for the duration of the works.

The map below shows the location of the closure on Harvil Road

We have installed advanced notification signage before our works commence.

The road will be closed throughout.
