What are we doing?

HS2 Ltd will be carrying out works within your area over the next three months.

They are being carried out on behalf of HS2 Ltd by our contractors. Affinity Water will do the utility works, Cadent will do the gas works, and Costain-Skanska Joint Venture (CSJV) will do site clearance and biodiversity habitat creation.

Cadent works: Harvil Road

These works have already started and we have previously notified you of these. Cadent need to divert two of their existing gas pipelines so the gas supply in the area continues. Cadent contractors are carrying this work out.

The site office and the works are taking place on land off Harvil Road, between Harefield and Ickenham in Hillingdon.

As part of these works they will be tunnelling under the existing Chiltern Mainline and the HS2 route. To do this, two shafts will be built. The southern shaft at the works site off Harvil Road, and the northern shaft in Newyears Green Covert.

The works will also involve digging a trench from the existing pipeline north of the Chiltern Mainline near Hanson Ready-mixed Concrete to a point south of the Dogs Trust.

The map below identifies the locations of the works.



How will this affect me?

Duration: Work has already started from August 2017 to December 2018

Working Hours: Due to the complex nature of these works, we will need to work 24 hours a day. We do not anticipate noisy works or disturbance but you may see people on site throughout the night or in the early morning.

What to expect

Locally sourced construction materials

15 HGV movements, with increases for small periods during shaft construction

There should be no disruption to your utilities during this time

Affinity Water: Breakspear Road South

Affinity Water will be installing a new pipeline across Breakspear Road South and then tunnelling underneath the Chiltern Line and connecting north of Affinity Water's existing pumping station. The pipeline is an important supply for the Watford area and we need to carry out these works to continue a safe and reliable water supply and provide what's needed for the increasing demand for water in the South East of England.

How will this affect me?

Duration: February 2018 to early 2019

Working Hours: Monday to Friday 8am to 6pm, during the preparation period, and workers may also be on site for an hour before and after each shift. We will also need to work 24 hours a day when work starts on installing the pipeline. We do not anticipate noisy works or disturbance but you may see people on site throughout the night or in the early morning.

What to expect:

February 2018

Affinity Water contractors will prepare the area for installing the pipeline. This will include vegetation and tree clearance and discreet hedgerow crossings. This will be followed by surveys and ground investigation activities.

March to May 2018

Barhale on behalf of Affinity Water will set up temporary access routes and compounds to allow further works to take place. This will include trial holes, archaeological investigations, vegetation and tree clearance in the flood plain, together with connections to the existing water mains.

June 2018 to early 2019

Barhale on behalf of Affinity Water will start work on installing the pipeline. The work is expected to be completed by early 2019. We'll be setting up two construction sites in field locations off Breakspear Road South. Our site, equipment and work will be taking place within private and HS2 land with one road crossing off Breakspear Road South.

Most of the diversion work involves digging a trench with a bored underground tunnel underneath the existing Chiltern Line. Deliveries will take place to the main compounds and the majority of construction movements will occur on the temporary access on private land.

While we do not anticipate these works to cause any major disruption, or for there to be any effect on local water supply, we recognise the disturbance this work can create and apologise in advance.

Costain-Skanska Joint Venture (CSJV): Breakspear Road South

CSJV will be carrying out preparation works on behalf of HS2 Ltd. Part of this work will be creating a habitat for endangered species that need to be relocated from areas that are impacted from our works.

The new habitat will include four ponds and a number of new tree shrubs that will be planted within an area of land adjacent to the Merck, Sharp and Dohme Animal Health Research Facility (MSD Animal Health site) off Breakspear Road South. A map of the intended pond locations can be seen below:



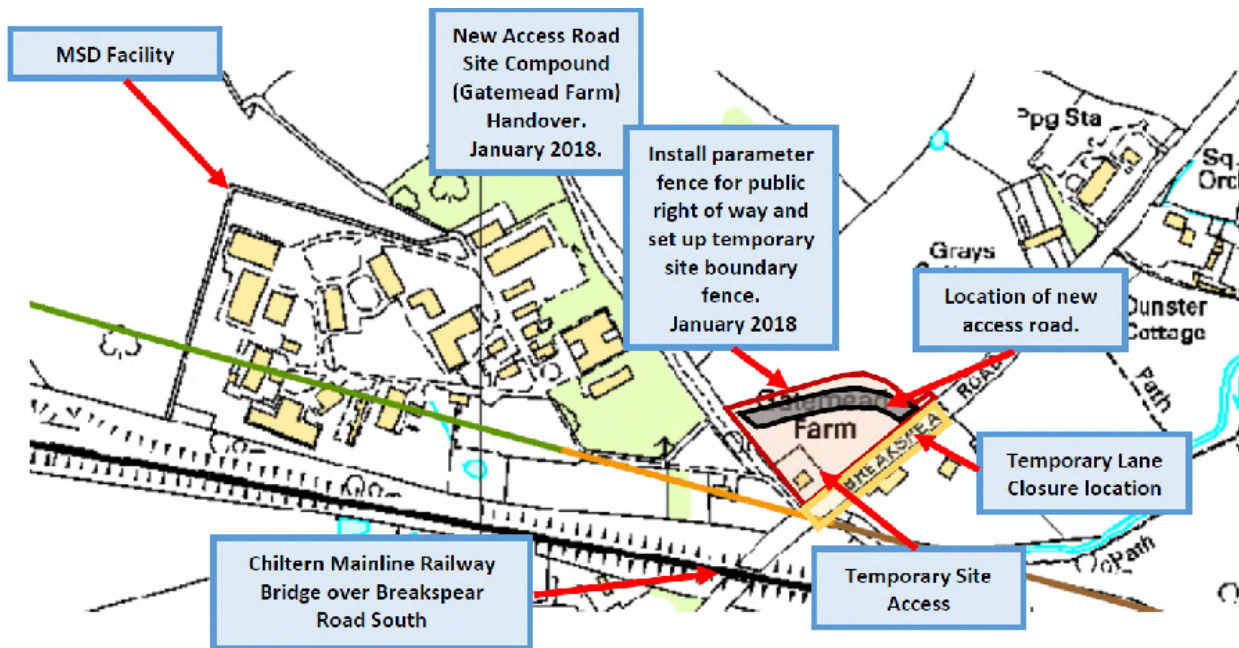
There will also be some land surveys on Breakspear Road South which will be carried out at night to ensure no disruption to road users. These surveys are required to map the profile of the ground to help design the new road to the MSD Animal Health site which will be constructed from the site. These works are anticipated to commence on 26 February 2018. These working hours are from 10pm at night until 6am in the morning.

In January, we told you about a three-week northbound lane closure on Breakspear Road South to enable the site set-up and security hoarding of a construction site compound adjacent to the MSD Animal Health site. The lane closure is anticipated to commence in early March 2018. The map below shows the site set-up activities:



How will this affect me?

Duration: Mid-February to late April 2018

Working Hours: Habitat creation works will take place Monday to Friday 8am to 6pm and workers may also be on site for an hour before and after each shift. Land surveys will take place at night between 10pm and 6am

What to expect:

- We do not anticipate that the habitat creation work will be disruptive
- Traffic management will be in place for the night time land surveys. They will consist of traffic cones to ensure the safety of the workers
- Three week road closure on Breakspear Road South anticipated to commence in early March
