### Ground Investigation Ruislip Golf Course

High Speed Two (HS2) is the new high speed railway for Britain. Initial works on Phase One of HS2, from London to the West Midlands, have now started.

#### What are we doing?

Further to the HS2 programme of ground investigation in 2017, we will be carrying out some additional ground investigation surveys in West Ruislip, Hillingdon. The results of these surveys will build on the information we already have from the work done in 2017, helping us get a better understanding of the ground and groundwater conditions. The work will be carried to the southern side of Ruislip Golf Course.

#### How will this affect you?

We will drill down into small sections of the ground. Monitoring equipment will then be installed below a secure cap. In some cases, we will return to monitor for up to 12 months after we have left the area. The activity areas will be surrounded by protective barriers and acoustic screens to reduce noise.

Work is planned to start from the week beginning 7 January and will take up to four weeks. Most of the work is scheduled to take place between 8am and 6pm on Mondays to Fridays and on Saturdays between 8am and 1pm if needed. To facilitate our work, a generator may need to run for a period while we carry out tests.

#### **Duration of work**

- Week beginning 7 January 2019 for up to four weeks
- Working hours are 8am to 6pm on Mondays to Fridays and Saturdays between 8am and 1pm if needed

#### What to expect

- Sites secured with protective barriers and acoustic screens to help reduce noise


