# Update to notice of West Ruislip Golf Course Possession

High Speed Two (HS2) is the new high speed railway for Britain. As part of the railway's construction we are continuing preparatory works within the Hillingdon area.

## Ruislip Golf Course Closure

Ruislip Golf Course closed on 2 September. During these works the footpaths which are public rights of way will be maintained but the site will be closed to vehicles.

The Fairway Pub remains open for business. Ruislip Golf Club will also continue to operate as a members' organisation, while the course is closed.

We have worked to keep the golf course open to the public for as long as possible, however we are now at the stage where closure of the golf course is unavoidable.

We need to carry out archaeological investigations along the southern part of the course. The area was identified as potentially being of archaeological importance and there is a limited timeframe to explore this before we begin construction works.

## What works will be happening?

This archaeology work is vital in determining the nature, character and extent of any archaeology that may be present in the area. In readiness for the archaeology works there will be a realignment of the existing fence line to protect the work sites.

We will also be removing vegetation and trees in preparation for handover of the site to the main works contractor.

As well as the archaeology works, Thames Water will be carrying out some ground investigations within the golf course site. These works will take place on an ongoing basis.

To ensure the safety of the public and to keep the site secure we have:

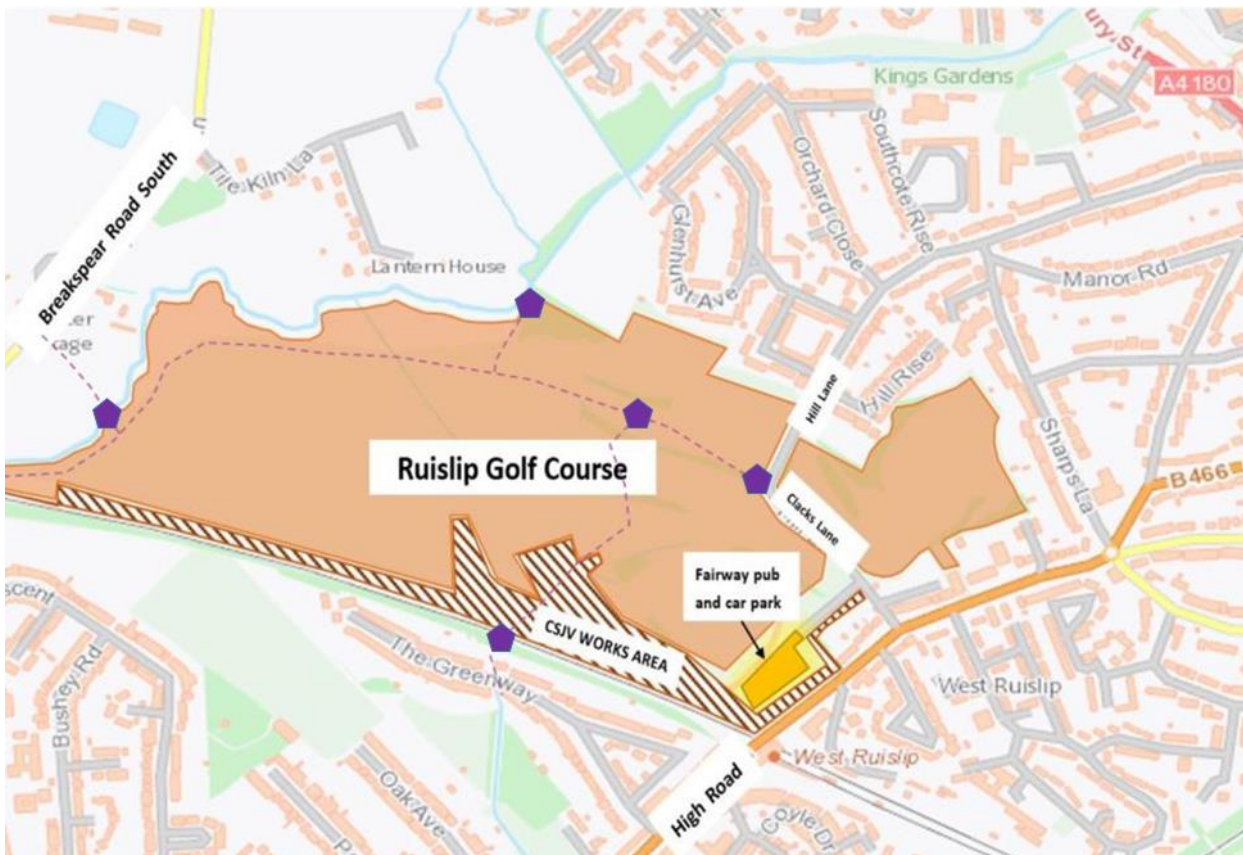
- Installed temporary fencing along Clacks Lane and around areas of the golf course
- Put in place 24 hour site security
- Introduced two security camera towers at Clacks Lane entry point and within groundkeepers compound to protect the area from fly tipping
- Installed metal fencing alongside the access route leading in the golf course car park
