High Speed Two (HS2) is the new high speed railway for Britain.

As part of the construction, HS2 are continuing preparatory works within Mandeville Road vent shaft site.

Mandeville Road lane and foot path closure postponed

We have previously written to you about a southbound lane and foot path closure on Mandeville Road, required for modification works to the entrance to our site. These works have now been re-programmed for April 2019 and we will provide further detail prior to works commencing.

Vegetation clearance

To allow our main works contractor to set up their work site and compound, vegetation clearance is required at the Mandeville Road Vent Shaft site. This will include removal of trees, grass, shrubs and bushes and will cover an area of 8000 m2 located within the boundary of Network Rail. This is east of Northolt Station and to the north of the railway tracks, highlighted in the map on *page 2*.

How will this affect you?

You will see staff in orange high visibility clothing carrying out site clearance. The works will involve the use of machinery however noise will be kept to a minimum. We apologise for any inconvenience these works may cause.
