High Speed Two (HS2) is the new high speed railway for Britain. Cadent will be moving underground gas pipelines in the Coleshill area to allow for the construction of the new railway and to continue to ensure a safe and reliable gas supply.

We started main works to move one of these pipelines at the beginning of July 2019 and will be starting the next phase of the works in October 2019. We expect all our work in the area to be completed by October 2020.

What are we doing?

The next stage of our works will be to construct a shaft in the field off Gypsy Lane. This will enable us to use a boring machine to tunnel the route of the new pipeline. As our work in the area progresses, we will also need to access the field south of Gypsy Lane.

After an ongoing discussion with the Local Authority, Gypsy Lane will be closed from November 2019. This is to facilitate the safe access of our construction traffic while we carry out the pipeline diversion.

We expect the road to remain closed until we complete our work in October 2020. We will put signs in place to make sure everyone is aware of the road closure and the diversion route for traffic.

We will continue to use our existing main works compound off Watton Lane as our main works site.

How will this affect you?

We apologise for any inconvenience caused by the closure of Gypsy Lane. Our tunnelling work is underground so we do not anticipate any additional noise or disruption for local people. Work will take place inside usual working hours.

There will be 24-hour security on site so we can maintain a safe working environment. Please note, there will be no on-site lodging.

There will not be any disruption to your utilities during our works.

We will make sure we keep people up to date as our work progresses.
