

Notice of ground investigation works



High Speed Two (HS2) is the new high-speed railway for Britain which will provide a vital transport link for the country. Initial works on Phase One of HS2, from London to the West Midlands, have now started. These early works are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

We will be in your area to carry out ground investigation surveys. These surveys will allow us to identify utilities located along a short section of **Crackley Lane between Cryfield Grange Road and Blind Lane**. These surveys will be carried from **Monday 4 February and are expected to take four working days**, subject to permits and site conditions.

The road will be closed throughout this period. Access will be maintained for emergency vehicles and to all households along the



route. An agreed and clearly signed local diversion will be in place.

Duration of works

From 4 February for up to 4 working days.

Daytime working hours from 9.30am to 3.30pm.

Our contractors may also be on site for up to one hour beforehand to set up the works.

What to expect

Some noise from on-site machinery during working hours.

Disruption to traffic. A diversion will be in place during these works.

Access for pedestrians and cyclists will be maintained.

Inform you in advance of any changes.

Keep all sites safe and secure.
