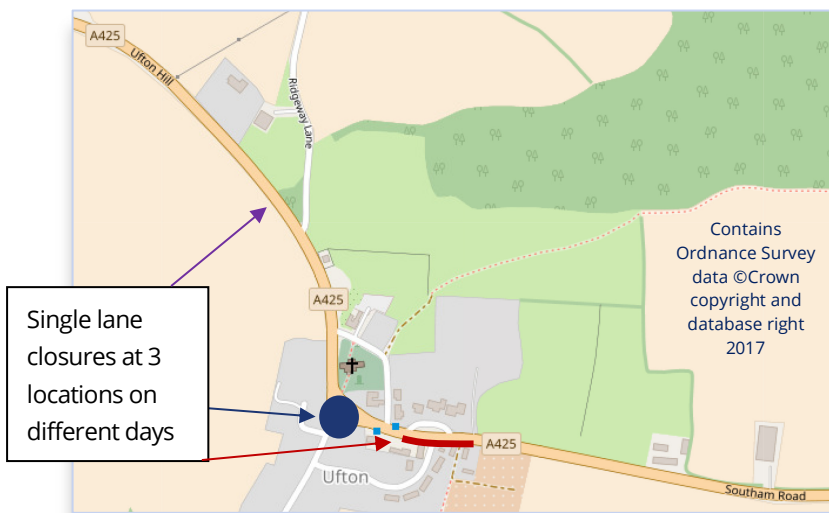
High Speed Two (HS2) is the new high speed railway for Britain. Initial works on Phase One of HS2, from London to the West Midlands, have now started. We will be carrying out surveys in your area as part of early works to prepare and clear the route ready for the main construction of the railway.

How will this affect me?

In order to carry out these works, we will need to install temporary traffic restrictions at three different locations in your area. You can see which areas these will be placed in the map below.

When will these works take place?

This work will be carried out from Monday 20 August 2018 and last up to four days. The work will be carried out in one location at a time. Controlled temporary traffic restrictions using portable traffic signals will be in place on each day from 9.30am, with restrictions lifted and the road fully re-opened by 3.30pm.

Duration of work

- For up to four days from **Monday 20 August 2018** between **9.30am to 3.30pm** only, on each day.
- Our contractors may be on site for up to one hour beforehand and afterwards to set up and close-down the works.

What to expect

- Some noise from the site during working hours
- Small increase of vehicles travelling to and from site
- Some traffic disruption

- Inform you in advance of any changes
- Keep all sites safe and secure
- Maintain access to properties at all times
