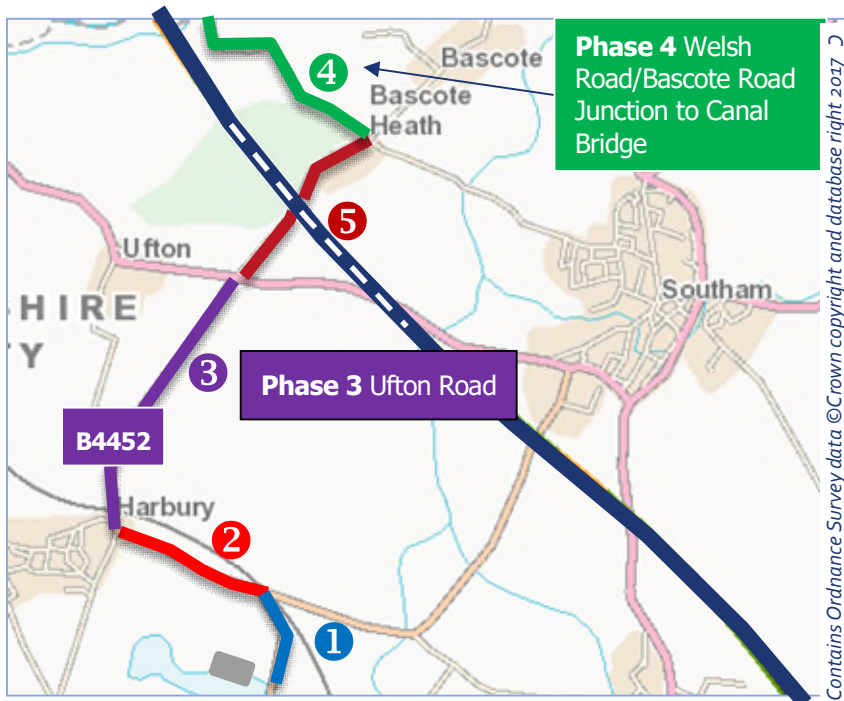
## Long Itchington Wood Tunnel utilities – phase 4

High Speed Two (HS2) is the new high speed railway for Britain. Initial works have now started and are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

We will be continuing our works to install utilities including power, telecoms and water to the tunnel compound.

Phase 1 and 2 are complete. Phase 3 is due to be completed by 16<sup>th</sup> August. **Phase 4 will start on 19<sup>th</sup> August for approximately 16 weeks** where a section of Welsh Road will be closed between the Bascote Road junction up to the Grand Union Canal Bridge. Access will be maintained for all households and businesses along the route. A clearly signed local diversion will be in place. Our contractors may also be on site for up to one hour beforehand and after to set up and demobilise the site.
